Terms and condition

- 1 The Tender Paper can be obtained from the Block Development Officer, Gopabandhunagar on payment of Cost of the tender paper (non refundable) in shape of cash.
- 2 The Tender Paper will be sold from date 01/10/2022 to 25/10/2022 on working days only from 10.30 AM to 4 PM in the office of the Panchayat Samiti, Gopabandhunagar.
- 3 The sealed Tender Paper will be received on working days till 05.30 PM from date. 01/10/2022 to 25/10/2022. The same should be submitted either through registered/ speed post addressing to the BDO, Gopabandhunagar or same may be dropped in the tender box kept in the Block office, Gopabandhunagar during working hour. The sealed envelope shall be superscripted as "Tender Paper" <Name of the Project & Sl. No. > The undersigned will not be held responsible for any delay in the postal service.
- 4 The Tender Paper will be opened on 11.30 AM on date. 26/10/2022 in presence of the bidders or their authorized representatives and Block Tender Committee in Block Conference Hall.
- 5 No EMD is required but, the bid security declaration must be submitted by the tenderer to the Block Development Officer.
- 6 The following documents should be furnished along with the tender paper failing which the tender is liable for rejection.
 - a. Original Money receipt of DTCN (Tender Paper).
 - b. Bid security declaration.
 - c. Self Attested copy of the contractor valid registration certificate/ License.
 - d. Self Attested copy of PAN CARD/ Labour License/GST clearance Certificate.
 - e. Self Attested copy of valid GST registration Certificate.
 - f. Attested copy of caste certificate for SC/ST contractor desirous of availing preference, if applicable
 - g. Self Attested Copy of PH Certificate for differently-abled Contractors, if Applicable
 - h. Affidavit for Engineer contractor, if any
 - i. Signed copy of DTCN and price bid duly filled in and signed by the tenderer.
 - j. An affidavit regarding authenticity of the credentials.
 - k. Name of the Project & Sl No will be mentioned in the cover of the envelop.
 - l. Mailing address registered office/site office of the bidders for future correspondence.
- 7 The Tenderer has to show all required original documents at the time of opening of the tender for verification.
- 8 Joint Stock Companies/ Joint Ventures are not allowed to participate in the tender process.
- 9 If the rate quoted by the Tenderers is found to be same, Tender Committee will take the final decision.
- 10 Excess bid amount quoted by the bidder, if any, in respect of any work shall not be accepted.
- 11 All the tenders where rate quoted is more than 15% less than the scheduled rate will be rejected.
- 12 The tender is to be submitted in sealed envelope with all documents described and required as per the relevant clauses of the DTCN and Special Conditions if any. The envelop to be superscripted as the bid of the work as mentioned in column No.3 of tender call notice.
- 13 ST/SC and differently abled Contractors can avail facilities as per Govt. circular.

- 14 Additional performance Security deposit shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of Additional performance Security(APS) as per the opwd code in shape of Demand Draft/ Term Deposit Receipt pledged in favour of Block Development Officer, Gopabandhunagar within Seven days, otherwise the bid shall be cancelled and the further, proceeding for blacklisting shall be initiated against bidder.
- 15 All bids received with remain value for a period of 90days from the date of receipt of bids or till the date of drawl of Agreement whichever is earlier and validity of bids can also be extended if agreed by the bidder and the Department/Office
- 16 If the L-1 bidder does not turn up for agreement after finalization of tender, than she/he shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case L-2 bidder if fulfill, other required criteria would be called for drawing agreement for execution of work subject to the condition, that L-2 bidder negotiate at par with the rate quoted by the L-1 bidder otherwise tender will be Cancelled.
- 17 The rates to be quoted by the contractor shall be excluding GST. The implementation of the GST rules by the Govt. of Odisha is to be accepted by the bidder from time to time.
- 18 The authority Reserves the rights to reject or cancel any or all the Tender without assigning any reason thereof.
