
General Instructions For Bidders along with Terms and Conditions

1. Procedure

- (a) The Bids have been invited under two bid systems, i.e., 'Technical Bid' and 'Financial Bid'. The interested Bidders are advised to submit two separate sealed envelopes super scribing **Technical Bid** and **Financial Bid**.
- (b) Technical Bid and Financial Bid – The bidders have to fill up the **Technical Bid form (Format-A)** (copy enclosed) and submit it with a separate envelope with all self-attested documents. Similarly, the **Financial Bid** form has to be filled up as per prescribed form **(Format-B)** (copy enclosed) and to be submitted in separate envelopes.
- (c) The Bidders should be a Registered Firm under GST Act. The tender should be addressed to the District Welfare Officer, Mayurbhanj, PO, Malkajgiri, Malkajgiri, PIN-757002 and superscribed as '**Tender for Supplying Fire Extinguisher**'
- (d) The interested Bidders have to enclose self-attested photo copy of the following valid self-attested documents in the Technical Bid envelope.
 - a) Valid company authorisation Certificate of the item
 - b) Firm Registration Certificate
 - c) Copy of PAN Card
 - d) Up to date GST Return Certificate
 - e) Last Financial Year's IT Returns (2021-22)/Assessment Year 2022-23
 - f) Experience in Govt. Supply (if any, not mandatory)
 - g) Bank Account Number (Cancelled Cheque)
 - h) Declaration as per Format-C (Copy enclosed)
- (e) The acceptance of the tender shall be based on the submission of all the valid documents as well as the sample as per specification mentioned. The technically disqualified bidders will not be entertained in the Financial Bid at any cost.
- (f) The quoted rates should be inclusive of all taxes except GST. The GST Charges on the quoted item must be clearly mentioned.
- (g) Non-refundable paper cost of Rs.2000/- (Rupees Two Thousand), in shape of Demand Draft, payable to the District Welfare Officer, Mayurbhanj should be attached in the Technical Bid. Technical Bid without Demand Draft of Rs.2000/- , the tender paper shall not be accepted and liable to be rejected.
- (h) The Committee shall not be responsible for any postal delay. The incomplete tender papers or without paper cost or received after the scheduled date and time shall not be accepted and liable to be rejected.
- (i) The Bidders should quote rate for each items/ article given in the tender schedule.
- (j) The rate inclusive of all taxes and transportation to the hostel points and installation in complete way and of good conditions.
- (k) If the Bidder fails to supply the required items within due time, the Supply Order will be cancelled and the L2 Bidder may be offered to supply the same item in L1 Price.

- (l) The District Level Purchase Committee shall not be bound to accept the lowest rate, but the acceptance of the tender shall be based on the best quality of the materials/ Samples submitted. The finally accepted bidders shall strictly confirm to the approved rates and sample while supplying the materials.
- (m) Supply of article other than sample approved, will warrant cancellation of Supply Order.
- (n) Supply order may increase or decrease subject to availability of funds
- (o) The Committee reserves the right to reject or cancel the tender/ quotation or supply orders without assigning any reason thereof.
- (p) Any dispute arises out of this tender shall be settled within the jurisdiction Mayurbhanj district.
