Sub: Inviting Application for the District level Awards to Outstanding Youth Club (AOYC) 2022-2023

Sir/Madam,

The scheme of Awards to Outstanding Youth Club is implemented by NYKS to encourage the growth of Youth Clubs, which are recognised as catalysts of social change. The scheme is operated at three levels i.e. District, State and National level. At district level, the winner is awarded Rs. 25,000/-. At State level the First, Second and Third winners are awarded Rs. 75,000/-, Rs.50,000/- and Rs.25,000/- respectively. At National level the First, Second and Third winners are awarded Rs. 3,00,000/-, Rs.1,00,000/- and Rs. 50,000/- and a Scroll/ Certificate, respectively.

In this regards, Nehru Yuva Kendra Mayurbhanj invites application for the Awards to Outstanding Youth Club (AOYC) at District level for the year 2022-2023 based on the activities of previous financial year 2021-2022 (i.e., 1<sup>st</sup> April 2021 to 31<sup>st</sup> March 2022)

## Eligibility:

- Youth Clubs affiliated with NYK Mayurbhanj District and registered under the Society Registration Act 1860 or Corresponding Act of State/UT are eligible to apply.
- Audit report (2021-2022) of the Applicant Youth Club is mandatory.
- The Youth Clubs who have been given award under the Scheme of AOYC during last 2 years will not be eligible to apply.

Last Date for submission of Application with all required Documents in 12<sup>th</sup> December 2022.

Selection will be done by the designated committee. Winner at the District level will automatically qualify for State level competition. The winning Youth Club to utilize the award money in the Community Development Projects and Programmes.
