BID SECURITY: The Bidders are required to submit the Bid Security along with their BID & a "BID SECURITY DECLARATION" as per the Office Memorandum No.18281 dated 31.12.2021 of Works Department, Govt. of Odisha in lieu of Bid security in the format annexed as per Annexure-A1. The Bid without security "Bid Security Declaration" will summarily be rejected.
- 4. Additional Performance Security (APS) shall be deposited by the successful bidder before drawl of the agreement as per Works Department Office Memorandum No. 4559 dated 05.04.2021 within 7 days of issue of L.O.A. by the Divisional Officer (Through email.) otherwise the bid of successful bidder will be cancelled & bid security, if any shall be forfelted at following rate as prescribed by State Govt.(Details as per DTCN)
- The Bid documents will be available in the website: www.tendersorissa.gov.in from 10.00 AM of dt.08.12.2022 to 5.00 P.M. of dt.18.12.2022 for online bidding.
- 6. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-III or Class-III.
- Bids shall be received only "on line" on or before 5.00 PM of dt.18.12.2022.
- 8. Bids received on-line shall be opened at 11.00 AM on dt.19.12.2022 in the office of the Divisional Forest Officer, Baripada Forest Division in presence of the bidders, who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 9. The cost of tender paper as indicated in Column No.6 shall be received vide O.M. No.6785 dt.09.05.2017 and No.17254 dt.05.12.2017 of Works Department. The procedure of bid submission using electronic payment of tender paper cost by the bidder may be referred to Works Department No.17254 dt.05.12.2017 which has been added in the DTCN.
- 10. Engineer contractor who wants to avail EMD exemption shall have to furnish scan copy of affidavit along with tender, declaring therein that he/she has not yet availed three Nos, of EMD Exemption during this financial year and to show the original registration certificate to the tender opening authority for verification without which the tender will be rejected. SC/ST contractor desires of availing benefit as per works Department resolution No.27748 dt.11.10.1977 and amendment thereto must submit affidavit for the same alongwith attested copy of caste certificate.
- 11. Agreement shall be drawn only after due verification of EMD & APS of the successful bidder. If any fake instruments are detected, criminal proceedings will be initiated against the defaulting bidder and action will be initiated for blacklisting through the license issuing Authority.

- The authority reserves the right to reject/cancel any or all bids without assigning any reason thereof.

Note: Period of completion is to be strictly followed. No extension of time shall be granted. Payment will be made as per the availability of funds.
