- Any damage caused during transport is the sole responsibility of the supplier.
- Block may conduct seed germination test on random basis before distribution to beneficiaries.
- Seeds should be supplied within 15 days of issue of supply order at BMMUs, OLM.
- The authority reserves the right to accept or reject any tender without assigning any reason thereof.
- The bidder shall furnish Photocopy of PAN card & GST Registration certificate (not applicable for SHG/GPLFs)
- The bidder shall submit refundable EMD amounting to Rs.2000/- as DD in favour of "Odisha Livelihoods Mission (NRLM), Mayurbhanj payable at SBI, Main Branch, Baripada.
- The bidder shall submit a sample of the product as per the specification. The specification shall be strictly adhered to.
