Terms and Conditions

1. Teacher engaged in contractual basis, would have no claim or right for appointment on a regular basis nor will they be a part of the cadre of teachers of Odisha Adarsha Vidyalayas.
2. Teacher appointed on contractual basis will not be entitled for vacation pay during summer/Autumn/Winter break. Payment shall be calculated on pro rata basis.
3. Teacher will not be entitled for pay, if remains absent on working day. In case of absence from duty, payment will be calculated on pro rata basis.
4. Working hours shall be same as regular teacher.

5. The engagement of these contractual teacher will automatically come to an end once a regular/contractual teacher is appointed/engaged against the vacant post in OAV.
6. The teacher engaged should not be allowed to take class on holiday and vacations and they shall not also be engaged in any examination duty except internal examinations of the school.
7. The teacher so engaged shall also be entrusted with correction and valuation work of the concerned subject in the OAV and he/she shall not be entitled for extra remuneration for such works.
8. The performance of the teacher will be reviewed on regular basis. If any teacher is found to be non-performing or engaged in activities amounting to misconduct he/she shall be disengaged forthwith by Principal.
9. Unauthorized absence for a continuous period of 15 days or more will automatically terminate his/her engagement
10. The temporarily engaged personnel shall be entitled to travelling allowance and daily allowance@ of the corresponding rank in regular Govt. Service when he/she discharge official duty/responsibility.
