INVITATIONS FOR BIDS (IFB)

The Block Development Officer, Jashipur invites percentage rate bid tender on behalf of Governor of Odisha from registered and eligible civil contractor of the state PWD (R&B)/ WR/ Rural Works/ MI/ CPWD for the construction works list detailed in the Enclosed "**Annexure-A**" eventually to be drawn up in the PWD PI Form in confirming with the detailed Tender Call Notice.

- 1. Cost of Tender Paper:** Bids must be accompanied by paper cost of the amount specified for the work in the table (Col No.6) in **Annexure-A** column in shape of Cash (non-refundable) drawn in any **Nationalized Bank** in favour of **BDO, Jashipur**, and payable at **Bank of India, Jashipur**
- 2. Earnest Money Deposit:** The bid must be accompanied with financial instruments towards E.M.D in shape of BID security Declaration as provided in Memorandum No.4710 dt. 12.04.2022 of works Dept. Govt. Of Odisha. The details of the bid Security format is at "**Annexure-B**".
- 3. Bid Security Declaration:** The Bid Security Declaration has been kept as per works deptt. O.M. No.-4710 dt:12.04.2022.
- 4. Sale and Receipt of Tender Paper:** The sale of the Bid documents will start from the date of publication i.e., from dt: **02.01.2023** to **19.01.2023 up to 05.00 P.M.** on working days. Bid should be received at the office of **Block Development Officer, Jashipur, MAYURBHANJ**, through **Speed post/Regd. post/Courier only** (No tender paper will received by hand service) and superscribed as "**NAME OF WORK**" **BID IDENTIFICATION NO- B.D.O,Jashipur** (Written in Capital letter) on the Body of cover. The last date of receipt of the bid documents will be dt: **19.01.2023 up to 05.00. P.M.**
- 5. Date of Opening of the tender Paper:** The Bids will open on **20.01.2023 at 11.00 A.M.** at the, **Conference Hall, Panchayat Samiti, Jashipur, MAYURBHANJ** in the presence of the bidders who wish to attend. If the office happens to be closed (holiday) on the date of receipt/opening of the bids as specified, the bids will be received/opened on the next working day at the same time and venue without further notice. However, date of tender paper opening may be postponed as per the convenience of the authority by intimating all the concerned tenderers through notice affixing to notice board at Office of the Block Development Officer, Jashipur, Mayurbhanj.
- 6. Additional Performance Security Deposit:** **Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender as per works deptt. Letter No.4710 dt. 12.04.2022. In such an event, only the successful bidder who has quoted less bid price/rates than the estimate cost put to tender shall have to furnish the exact amount of differential cost i.e., Estimated cost put to tender minus the quoted amount as additional performance security(APS) in shape of N.S.C/K.V.P/ Postal time deposit pass book/Term Deposit receipt duly pledged in favour of BDO, Jashipur within seven days, otherwise the bid shall be cancelled and the**

security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder.

Bellow 5%	:	No Additional Performance Security
From 5% & above and below 10%	:	50% of (Difference between estimated cost put to tender and Bid amount.
From 10% and above	:	150% of (Difference between estimated cost put to tender and Bid amount.

7. The following Documents should be furnished with the tender paper failing which the tender is liable for Rejection.

A) EMD Pledged in favour of BDO Jashipur.

B) BID Security Declaration should be furnished as per format attached in "Annexure-B"

C) Attested copy of valid Contractor Registration Certificate.

D) Attested copy of valid Pan Card & GST Clearance Certificates.

E) SC/ST Contractors submit original Affidavit in support of cast certificate and attested copy Of Cast certificate.

F) Bank Draft towards cost of Tender paper in favour of BDO, Jashipur.

8. Engineering Contractors desiring to avail the exemption facility of EMD should submit an original affidavit as regards, the fact of availing award of work without submission of EMD/ISD during the current financial year. He should also produce original contract licence at the time of opening of tender document to make necessary entry to that effect as such facilities are limited to three participation in tender during a financial year. Otherwise, their tender will be liable for rejection.

9. The SC/ST Contractors desirous of availing preference should submit an original affidavit in support of caste certificate and attested copy of caste certificate, Otherwise their tender will be liable for rejection.

10. G.S.T. as applicable shall be paid extra over and above the work value. The Contractor shall however be required to submit the TAX INVOICE along with the R.A. / final bill released of the G.S.T. amount by the department.

11. Shortfall of any required documents, Tender paper is liable for rejection.

12. A bidder can submit only one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular tender will liable for rejection of all such tender papers.

13. Other details can be seen in the bidding document.

14. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.

15. Bid documents will be available at District NIC website will be accompanied by Paper cost of the Tender paper in shape of Demand Draft payable at Bank of India, Jashipur and DTCN with all relevant documents of bidders as mentioned in Tender Call Notice.
