3. **BID SECURITY:** The Bidders are required to submit the Bid Security along with their BID & a "BID SECURITY DECLARATION" as per the Office Memorandum No.18281 dated 31.12.2021 of Works Department, Govt. of Odisha in lieu of Bid security in the format annexed as per **Annexure-A1**. The Bid without security "Bid Security Declaration" will summarily be rejected.
4. Additional Performance Security (APS) shall be deposited by the successful bidder before drawl of the agreement **as per Works Department Office Memorandum No. 4559 dated 05.04.2021 within 7 days of issue of L.O.A. by the Divisional Officer (Through email.) otherwise the bid of successful bidder will be cancelled & bid security, if any shall be forfeited at following rate as prescribed by State Govt.(Details as per DTCN)**
5. The Bid documents will be available in the website: [www.tendersorissa.gov.in](http://www.tendersorissa.gov.in) from **10.00 AM of dt.27.01.2023 to 5.00 P.M. of dt.06.02.2023 for online bidding.**
6. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
7. Bids shall be received only **"on line" on or before 5.00 PM of dt.06.02.2023.**
8. Bids received on-line shall be opened at **11.00 AM on dt.07.02.2023** in the office of the Divisional Forest Officer, Baripada Forest Division in presence of the bidders, who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
9. The cost of tender paper as indicated in Column No.6 shall be received vide O.M. No.6785 dt.09.05.2017 and No.17254 dt.05.12.2017 of Works Department. The procedure of bid submission using electronic payment of tender paper cost by the bidder may be referred to Works Department No.17254 dt.05.12.2017 which has been added in the DTCN.
10. Engineer contractor who wants to avail EMD exemption shall have to furnish scan copy of affidavit along with tender, declaring therein that he/she has not yet availed three Nos. of EMD Exemption during this financial year and to show the original registration certificate to the tender opening authority for verification without which the tender will be rejected. SC/ST contractor desires of availing benefit as per works Department resolution No.27748 dt.11.10.1977 and amendment thereto must submit affidavit for the same alongwith attested copy of caste certificate.
11. Agreement shall be drawn only after due verification of EMD & APS of the successful bidder. If any fake instruments are detected, criminal proceedings will be initiated against the defaulting bidder and action will be initiated for blacklisting through the license issuing Authority.
12. Other details can be seen in the bidding documents.
13. The authority reserves the right to reject/cancel any or all bids without assigning any reason thereof.
