TERMS & CONDITIONS:


1. The envelope carrying the bid must be superscribed in capital letter "**TENDER PAPER FOR AUCTION SALE OF GOVT. JEEP**"
2. The intending parties may inspect the vehicle in the premises of the Tahasil Office, Raruan in any working day within the due date during office hour, i.e., from date 02.02.2023 to 16.02.2023 before submitting the tender. Each tender must accompany an earnest money deposit of Rs.3,250/- (Rupees three thousand two hundred fifty) only in shape of Bank Draft of Bank of India in favour of the Tahasildar, Raruan payable at Raruan which will be refunded to the bidders whose tenders are not accepted except in case of the successful bidder. The bid price offer shall not be less than the minimum (upset price) as mentioned above in each case.
3. The tender should be sent addressing to the Tahasildar, Raruan, At/P.O/P.S-Raruan, Dist-Mayurbhanj, Pin-757035 should reach the undersigned by Registered Post/Speed Post only on or before 16.02.2023 by 2.00 P.M. at the latest. No tender paper shall be accepted by hand. The tender receipt shall be opened the same day at 3.00 P.M. by the Tahasildar, Raruan in presence of the bidders or their authorized representatives. If, this day is declared as Govt. Holiday then, the tender will be received and opened on the next day as per the scheduled time. The undersigned will not be held responsible regarding late submission/receive of the tender in any manner.
4. The bidder should clearly mention the actual sale price proposed to offer for the auction sale of the jeep both in figure and words without any cutting or overwriting.
5. The highest bidder, whose tender is accepted, shall deposit 25% of the offered amount immediately after announcement. In case, the highest bidder fails to deposit the minimum 25% of the amount offered by him/her within 2 hours of completion of the tender opening, the 2nd highest bidder will be considered as the successful bidder.

6. The successful bidder shall deposit the balance 75% amount within 7 days. In case, he/she fails to make deposit of the total amount as per the tender within stipulated time, the deposit including the earnest money shall be forfeited. The EMD of successful bidder can be adjusted at the time of final payment of tender value in time.
7. The vehicle shall not be delivered to the highest bidder until full payment is made and requisite formalities are completed. Tools, equipments and spare parts shall not be delivered with the vehicle.
8. The successful bidder shall take permission and remove the vehicle from the Office campus of Tahasildar, Raruan within 7 days of deposit of the total bid amount. Custody or safe guard of vehicle shall be responsibility of the tenderer/party and no claim or complaint on that accounts shall be admissible.
9. On failure of removal of the vehicle within 15 days from the date of deposit of total bid amount, the successful bidder will have no right to claim the auctioned vehicle & the vehicle including sale price/E.M.D. deposited by the bidder shall be forfeited to Govt. and no claim will be entertained.
10. The authority reserves the right to accept or reject any or all tenders without assigning any reason thereof.


