

## **NOTICE FOR SALE OF USED AND CONDEMNED VEHICLE**

The General Manager, WATCO Division, Baripada invites sealed quotation in prescribed Proforma from GST registered bidders for disposal of one TATA Truck, one Maruti Omini Van and one Mahindra Jeep as is where is basis. The last date of receipt of sealed quotation is 3.00 P.M. of dt.17.03.2023 and the bids will be opened on dt.18.03.2023 at 4.30 P.M. in presence of the bidders or their authorized representative. For inspection and others details in respect of the concerned vehicles, interested parties can contact the Manager, WATCO Sub-Division, Baripada or Assistant Manager, WATCO Section-I, Baripada on any working day prior to the last date of receipt of quotation between 10.00 A.M. to 5 P.M.

### **TERMS AND CONDITIONS**

1. The Bid will be confirmed in favour of the Bidders quoting the highest rate in respect of the concerned vehicle. If a bidder quotes his rate for more than one Vehicle in his quotation the bid shall be confirmed only in respect of the individual vehicles for which he/she has quoted the highest rate.
2. Only those bidders shall be eligible for bidding, who are register under GST ACT and who submit copy of PAN and GST registration number.
3. To be illegible for bidding the bidders has to deposit refundable EMD as mentioned in the schedule below in shape of Bank deposit receipt of any schedule commercial Bank/ Post Office Time deposit/ NSC, dully pledged in favour of General Manager WATCO Division, Baripada which shall be refundable to the unsuccessful bidders within three days of confirmation of highest bid.
4. To be eligible for bidding the bidder shall submit written bid in closed cover in proforma as at Annexure-A for purchase of vehicle.

5. 25% of the bid amount is to be deposited by the highest bidder within 3 (Three) days of communication, whose bid will be provisionally accepted, by way of Bank Draft in favour of General Manager WATCO Division, Baripada after adjusting the EMD already deposited as mentioned in this Schedule. If the amount is not deposited the EMD will be forfeited and the Vehicle will be put to bid again and the bidder will be barred from participating in bid further.

6. On final acceptance of the bid, the remaining 75% amount is to be deposited by the highest bidder within the 15 days of communication of the acceptance to him, failing which 25% amount already deposited shall stand forfeited and vehicle will be sold through fresh bid. The vehicle shall be hand over to the bidder only after full payment is made and GST as applicable on old used vehicles is



deposited in Government account by the buyer through Treasury Challan (Copy of Which is to be produced before the General Manager WATCO, Baripada as a proof of deposit of GST) within the prescribed 15 days cited above. GST is payable by the buyer in addition to the bid amount for purchase of the Vehicle/Vehicles.

7. Conditional bidding will not be entertained. If the bid is withdrawn by the concerned party at any time after it is provisionally accepted, the entire money already deposited by him/her shall stand forfeited.


8. The disposed vehicle must be removed from the site by the bidder within 7 (Seven) days from the date of depositing the full value of the bid money. But it will be the responsibility of the bidder to look after the vehicle at his own expenses and the department will not be responsible for any damage done by way of pilferage or otherwise and no claim on this account shall be entertained.

9. In case the vehicle is not lifted within the prescribed time limit, ground rent at the rate of 10% of the bid amount for each day of delay will be charged. In case the ground rent exceeds the sale price deposited, the purchaser will cease to have any right on the disposed vehicle. The amount deposited towards the sale price will be adjusted towards the ground rent and the vehicle will become the absolute property of Government and disposed by fresh tender.

10. The successful bidder shall get the vehicle transferred on his/her name as per rules, at his own cost and responsibility.

11. The General Manager WATCO Division, Baripada in its discretion, reserves the right to reject or accept any or all the bids, partly or completely at any time without assigning any reason thereof. The decision of the competent authority accepting the bid shall be final.
