#### SCOPE OF WORK AND GENERAL INSTRUCTION FOR BIDDERS

- The Zilla Parishad, Mayurbhanj requires the service of reputed, well established and financially sound Human Resource Service Provider Agency to provide services of 1 number of DPC (District Project Co-ordinator), 1 no. of DPE(District Project Executive) & 1 no. of CCE( District Call Centre Executive) at DPMU and 26 no of BPCs(Block Project Co-ordinator) @1 (one) per Block and 26 no. of BPAs (Block Project Assistant) @ 1 (one) per Block at BPMU Block on contractual basis under Rural Housing Scheme for day to day official work.
- 2. The contract of providing the aforesaid manpower is likely to commence from 01.04.2023 and would continue till 31.03.2024. The Zilla Parishad, Mayurbhanj however, reserves right to terminate this initial contract at any time after giving one week's notice to the selected Service Provider.
- This Zilla Parishad, Mayurbhanj has tentative requirement for 55 number of staff for DPMU & BPMU under Rural Housing. The requirements may increase or decrease in any/ all the categories.
- 4. The estimated cost of the contract is Rs. 1,24,81,638/- (Rupees One Crore twenty four Lakh eighty one Thousand six hundred thirty eight) only.
- 5. The tender document can be downloaded from the website www.mayurbhanj.nic.in
- 6. The interested Manpower Service Providers may submit the tender document complete in all respects along with Tender paper cost of Rs. 10,000/- (Ten thousands) only & Earnest Money Deposit (EMD) of Rs. 2,50,000/- (Rupees Two lakh fifty thousand) only and other requisite documents by Dt. 24.03.2023 up to 5:00 PM to Zilla Parishad, Mayurbhanj. The Tender Paper cost is non refundable.

- 8. The tender has been invited under two bid system i.e. Technical Bid and Financial Bid. The interested agencies are advised to submit two separate sealed envelopes super scribing "Technical Bid for Providing Manpower Services for DPMU & BPMU Staff under Rural Housing to Zilla Parishad, Mayurbhanj" & "Financial Bid for Providing Manpower Services for DPMU & BPMU Staff under Rural Housing to Zilla Parishad, Mayurbhanj". Both sealed envelopes should be kept in a third sealed envelope super scribing "Tender for Providing Manpower Services for DPMU & BPMU Staff under Rural Housing to Zilla Parishad, Mayurbhanj".
- 9. The Tender paper cost of Rs. 10,000/- (Ten thousands) only and Earnest Money Deposit (EMD) of Rs 2,50,000/- (Rupees Two lakh fifty thousand)only, refundable (Without interest), should be necessarily accompanied with the Technical Bid of the service provider in the form of Demand draft/Pay order drawn in favour of CDO-Cum-EO, Zilla Parishad, Mayurbhanj failing which the tender shall be rejected summarily.
- 10. The successful bidder will have to submit Performance Security amount equivalent to 5% of the total quoted amount before execution of the agreement in the form of Bank Guarantees from Nationalized bank drawn in favour of CDO-Cum-EO, Zilla Parishad, Mayurbhanj covering the period of contract. In case, the contract is



further extended beyond the initial period, the Bank Guarantee will have to be accordingly renewed by the successful bidder.

- 11. The tendering Manpower Service providers are required to enclose photocopies of the following documents (duly attested by Group "A" Gazetted Officers of the Central Government / any Gazetted Officer not below the rank of Sub-Collector of the State Governments, along with the Technical Bid, failing which their bids shall be summarily / out rightly rejected and will not be considered any further:
  - (a) Registration certificate of the organization.
  - (b) Copy of PAN / GIR card;
  - (c) Copy of the IT return filed for the last three financial years;
  - (d) Copies of EPF and ESI certificates and latest return filed by the agency;
  - (e) Copy of the GST registration certificate and latest return filed by the agency;
  - (f) Copy of the Bank Account details of the organization.
- 12. The conditional bids shall not be considered and will be out rightly rejected in very first instance.
- 13. All entries in the tender form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting is permitted in the Financial Bid form. In such cases, the tender shall be summarily rejected. However, the cuttings, if any, in the Technical Bid Application must be initiated by the person authorized to sign the tender bids.
- 14. The Technical bids shall be opened on the scheduled date and time at 11:00 AM on Dt.27.03.2023 in the office of CDO-Cum-EO, Zilla Parishad, Mayurbhanj in the presence of the representatives of the Manpower Service providers, if any, who wish to be present on the spot at that time.
- 15. The Financial Bid of only those tenderers will be opened whose Technical bids are found in order. The Financial bids shall be opened after opening the Technical bids on Dt.27.03.2023 in the office of CDO-Cum-EO, Zilla Parishad, Mayurbhanj in the presence of the representatives of the Manpower Service Providers, if any, who wish to be present on the spot at that time.
- 16. The Competent Authority of the Zilla Parishad, Mayurbhanj reserves the right to reject all bids without assigning any reason.



# TECHNICAL REQUIREMENTS FOR THE TENDERING MANPOWER SERVICE PROVIDER

- 1. The tendering manpower service provider should fulfill the following technical specification.
  - a. The registered office or one of the registered branch office of the manpower service providers should be located within the jurisdiction of the user Zilla Parishad, Mayurbhanj / Office. Besides, if the Zilla Parishad, Mayurbhanj / Head of Zilla Parishad, Mayurbhanj / Controlling Officer are procuring manpower for deployment in their Field Office (s), the manpower service provider should provide the name, designation and contract number of the person to liaise with the said Field Office (s).
  - b. They should be registered with the appropriate registration authority.
  - c. They should have at least three years experience in providing manpower to Government Departments / Public Sector Companies / Banks, etc.
  - d. They should have their own Bank Account;
  - e. They should be registered with Income Tax and GST Department.
  - f. They should be registered with appropriate authorities under Employees Provident Fund and Employees State Insurance etc.
  - g. Affidavit by the bidders that the bidder has not been blacklisted by any Central/State Government/Public sector organization.
  - h. The Minimum annual turn-over of the company of last 3 years shall at least be 5 times of the present contract value.
  - The Agency must have executed contracts of similar type during preceding 3 years of value equal or more than 60% of the estimated cost of the present contract.

The payment shall be made on conclusion of the calendar month only on the basis of no. of working days for which duty has been performed by each manpower.



#### TERMS CONDITIONS

- The Agreement shall commence from 01.04.2023 and shall continue till 31.03.2024 unless it is curtailed or deployed, breach of contract etc or change in requirements.
- The Agreement shall automatically expire on 31.03.2024 unless extended further by the mutual consent of the manpower service provider and the authority.
- 3. The manpower service provider shall not be allowed to transfer, assign, pledge or subcontract its rights and liabilities under this agreement to any other agency or organization by whatever name be called without the prior written consent of the authority.
- 4. The Zilla Parishad, Mayurbhanj, at present has tentative requirement of 55 nos. of DPMU & BPMU Staff under Rural housing. The requirement of the Zilla Parishad, Mayurbhanj may further increase or decrease marginally, during the period of initial contract also and the tenderer would have to provide additional manpower service, if required on the same terms and condition.
- 5. The manpower service provider will be bound by the details furnished by it to the Authority while submitting the tender or at subsequent state. In case any of such documents furnished by it is found to be false at any stage, it would be deemed to be breach of terms of Agreement making it liable for legal action besides termination of the agreement.
- 6. The authority reserves the right to terminate the agreement during initial period also after giving 15days notice to the manpower service provider.
- 7. The person deployed shall be required to report for work at 10.00AM to the CDO-Cum-EO, ZP, Mayurbhanj or such other Officer as may have been kept in charge of the Office establishment of the Office concerned and would leave at 5.30PM and may also require to work beyond 5.30PM for which he would not be paid any extra remuneration. In case the person deployed remains absent on a particular day or comes late/leaves early on three occasions, proportionate deduction from the remuneration for one day will be made.
- 8. The person deployed should allowed special leave of 12 days at the maximum during the period of engagement for one year. The leave will not be carried over to the next year and will lapse on completion of each year of service.



- 9. The manpower service provider shall nominate a coordinator who shall be responsible for immediate interaction with the Zilla Parishad, Mayurbhanj, so that optimal services of the persons deployed could be availed without any disruption.
- 10. The entire financial liability in respect of manpower service deploy in the Zilla Parishad, Mayurbhanj or office concerned shall be that of the manpower service provider and the Zilla Parishad, Mayurbhanj or office concerned will in no way be liable. It will be the responsibility of the manpower service provider to pay to the person deployed a sum not less than the minimum rate quoted in the financial bid and adduce such evidences as may be required by the Zilla Parishad, Mayurbhanj or office concerned. If at any point of time it is found that the agency is paying to the candidate less remuneration, the agreement shall be terminated EMD & security deposits shall be forfeited.
- 11. The payment of remuneration to the manpower has to be through bank account only. No cash payment can be made to them.
- 12.For all intents and purposes, the manpower service provider shall be "employer" within the meaning of different rules and acts in respects of manpower so deployed. The person deployed by the manpower service shall not have any claim whatsoever like employer and employee relationship against the Zilla Parishad, Mayurbhanj or office concerned.
- 13. The manpower service provider shall be solely responsible for the redressal of grievances or resolution of disputes relating to person deployed. The Zilla Parishad, Mayurbhanj shall, in no way be responsible for settlement of such issues whatsoever. In case the Grievance of the deployed person are not attended to by the manpower service provider the deployed person can place their grievance before a joint committee consisting of a representative of the Zilla Parishad, Mayurbhanj office concerned and authorize representative of the manpower service provider.
- 14. The Zilla Parishad, Mayurbhanj shall be not be responsible for any financial loss or any injury to any person deployed by the manpower service provider in



- the course of their performing the functions/duties, or for payment towards any compensation.
- 15. The persons deployed by the manpower service provider shall not claim nor shall be entitled to pay, perks and other facilities admissible to regular/confirmed employees during the currency or after expiry of the Agreement.
- 16.In case of termination of this agreement in its expiry or otherwise the persons deployed by the manpower service provider shall not be entitled to and shall have no claim for any absorption in regular or other capacity.
- 17. The person deployed shall not claim any benefit or compensation or regularization of deployment with office under the provision of rules and acts. Undertaking from the person deployed to this effect shall be required to be submitted by the manpower service provider.
- 18. The manpower service provider must be registered with the concerned Govt. Authorities i.e. Labour commissioner, Provident fund authorities, Employees state insurance corporation etc. and a copy of the registered should be submitted. The manpower service provider shall comply with all the legal requirements for obtaining license under contract labour (regulations and abolition) act, 1970 if any at his own part of cost.
- 19. The manpower service provider shall provide a substitute well in advance if there occurs any probability of the person leaving the job due to his/her own personal reasons. The payment in respect of the overlapping period of the substitute shall be the responsibility of the manpower service provider. The manpower service provider shall be responsible for contributions towards provident fund and employee state insurance, whatever applicable.
- 20. The person deployed by the manpower service provider should have good police records and no criminal case should be pending against them.
- 21.The person deployed should be polite, cordial and efficient while handling the assigned work and their actions should promote good will and enhance the image of the Zilla Parishad, Mayurbhanj of office concerned. The manpower service provider shall be responsible for any act of indiscipline on the part of the person deployed.



#### LEGAL

- 22. The person deployed shall during the course of their work be privy to certain qualified documents and information which they are not supposed to divulge to third parties. In view of this they shall be required to take oath of confidentiality and breach of this condition shall make the manpower service provider as well as the person deployed liable for penal action under the application laws besides, action for breach of contract.
- 23. The manpower service provider shall be responsible for compliance of all statutory provisions relating to minimum wages payable to different types of worker in respect of the persons deployed by it in the Zilla Parishad, Mayurbhanj or office concerned shall have no liabilities in this regard.
- 24. The manpower service provider shall also be liable for depositing all taxes levies, cess, etc. on account of service rendered by it to the Zilla Parishad, Mayurbhanj or office concerned to the concerned tax collection authorities from time to time, as per the rules and regulations in the matter. Attested Xerox copy of such documents shall be furnished to the Zilla Parishad, Mayurbhanj or office concerned.
- 25. The manpower service provider shall maintain all statutory registers under the law and shall produce the same on demand, to the authority of the Zilla Parishad, Mayurbhanj of office concerned or any other authority under law.
- 26. The tax deduction at source(T.D.S) shall be done as per the provision as per the income tax act/rule, as amended from the time to time and certificate to this effect shall be provided by the Zilla Parishad, Mayurbhanj or office concerned.
- 27.In case the manpower service provider fails to comply with any liability under appropriate law and as result thereof, the Zilla Parishad, Mayurbhanj to the office concerned is put to any loss/obligation, monitory or otherwise, the Zilla Parishad, Mayurbhanj to the office concerned will be entailed to get itself reimbursed out of the outstanding bills or the performance security deposit of the manpower service provider to the extent to the loss or obligation in monetary terms.



28.Agreement is liable to terminated because of non-performance deviation of terms and condition of contract, non-payment of remuneration of employed person and non-payment of statutory dues. The Zilla Parishad, Mayurbhanj of office concerned will have no liability towards non-payment of remuneration to the person employed by the manpower service provider and the outstanding statutory dues of the service provider to statutory authorities. If any loss or damage is caused to the Zilla Parishad, Mayurbhanj or office concerned by the person deployed, the same will be recovered from the unpaid bills or adjusted from the security deposit.

#### **FINANCIAL**

- 29. The Technical Bid should be accompanied with an Earnest Money Deposit (EMD), refundable without interest of Rs 2,50,000/- (Rupees Two lakh fifty thousand)only in the form of Demand draft/ Pay order drawn in favour of CDO-Cum-EO, Zilla Parishad, Mayurbhanj failing which the tender shall be rejected out rightly.
- 30. The Earnest Money Deposit in respect of the agencies which do not qualify the technically bid (first state)/ Financial bid (second competitive stage) shall be returned to them. In case of successful tendered if the agency fails to deploy the required manpower against the initial requirement within 30days from date of placing the order, the EMD shall stand forfeited without giving any further notice.
- 31. The successful bidder will have to submit a Performance Security amount equivalent to 5% of the total quoted amount in the form of Bank Guarantees from Nationalized bank drawn in favour of CDO-Cum-EO, Zilla Parishad, Mayurbhanj covering the period of contract before execution of the agreement. In case, the contract is further extended beyond the initial period, the Bank Guarantee will have to be accordingly renewed by the successful bidder.
- 32. In case of breach of any terms and conditions attached to this agreement, the Performance Security Deposit of the manpower service provider shall be liable to be forfeited besides annulment of the agreement.
- 33. The manpower service provider shall raised the bill in duplicate along with attendance sheet duly verified by the Zilla Parishad, Mayurbhanj or Office concerned in respect of the persons deployed and submit the same to the



prescribed authority in the first week of the succeeding month. As per as possible the payment will be released by the second week of the succeeding month.

- 34. The claim in bills regarding Employees State Insurance, Provident Fund, GST, etc. should necessarily accompanied with documentary proof pertaining to the concerned bill month. A requisite portion of the bill or whole of the bill amount shall be held up till such proof is furnished, at the discretion of the Zilla Parishad, Mayurbhanj or office concerned.
- 35. The amount of penalty calculated @Rs.100 per day on account of delay, if any in providing a suitable substitute for the period beyond three working days by manpower service provider shall be deducted from its monthly bills in the succeeding month.
- 36. The authority reserve the right to withdraw or relax any of the terms and conditions mentioned above so as to overcome the problem encountered at a later stage.
- 37. In the event of any dispute arising in respect of the clauses of the agreement the same shall be resolved through negotiation. Alternatively the dispute shall be referred to the next higher Authority or controlling officer for his decision and the same shall be binding on all parties.
- 38. All disputes shall be under the jurisdiction of the court at the place where the headquarters of the authority, who has executed the agreement, is located.
- 39.The successful bidder will enter into an agreement with this Zilla Parishad, Mayurbhanj for supply of suitable and qualified manpower as per requirement of this Zilla Parishad, Mayurbhanj on the above terms and conditions.

### TERMS & CONDITIONS OF THE AGREEMENT

- The agreement shall commence from ..................(date) and shall continue till
  ........................(date) unless it is curtail or terminated by the authority owing to
  deficiency of service, sub-standard quality of manpower deployed, breach of
  contract etc or change in requirements.
- The agreement shall automatically expire on ..............(date) unless extended further by the mutual consent of the Manpower Service Provider and the authority.
- The agreement may be extended on the same terms and conditions or with some additions/deletions/modifications, for further specific period mutually agreed upon by the Manpower Service Provider and the authority.
- 4. The Manpower Service Provider shall not be allowed to transfer, assign, pledge or subcontract its right and liabilities under this agreement to any other agency or organization by whatever name be called without the prior written consent of the authority.
- 5. The Manpower Service Provider will be bound by the details furnished by it to the authority while submitting the tender or at a subsequent stage. In case any of such documents furnished by it is found to be false at any stage, it would be deemed to be breach of terms of agreement making it liable for legal action besides termination of agreement.
- 6. The authority reserves the right to terminate the agreement during initial period also after giving 15days notice to the Manpower Service Provider.
- 7. The persons deployed shall be required to report for work at 10.00AM to the CDO-Cum-EO, ZP, or such other officer as may have been kept in charge of the office establishment of the office concerned and would leave at 5.30PM and may also be required to work beyond 5.30PMfor which he would not be paid any extra remuneration. In case the person deployed remains absent on a particular day or comes late/leaves early on three occasions, proportionate deduction from the remuneration for one day will be made.
- 8. The manpower service provider shall nominate a coordinator who shall be responsible for immediate interaction with the Zilla Parishad, Mayurbhanj, so that optimal services of the persons deployed could be availed without any disruption.



- 9. The entire financial liability in respect of manpower service deploy in the Zilla Parishad, Mayurbhanj or office concerned shall be that of the manpower service provider and the Zilla Parishad, Mayurbhanj or office concerned will in no way be liable. It will be the responsibility of the manpower service provider to pay to the person deployed a sum not less than the minimum rate quoted in the financial bid and adduce such evidences as may be required by the Zilla Parishad, Mayurbhanj or office concerned. If at any point of time it is found that the agency is paying to the candidate less remuneration, the agreement shall be terminated EMD & security deposits shall be forfeited.
- 10. The payment of remuneration to the manpower has to be through bank account only. No cash payment can be made to them.
- 11.For all intents and purposes, the manpower service provider shall be "Employer" within the meaning of different rules and acts in respects of manpower so deployed. The person deployed by the manpower service shall not have any claim whatsoever like employer and employee relationship against the Zilla Parishad, Mayurbhanj or office concerned.
- 12. The manpower service provider shall be solely responsible for the redressal of grievances or resolution of disputes relating to person deployed. The Zilla Parishad, Mayurbhanj shall, in no way be responsible for settlement of such issues whatsoever. In case the Grievance of the deployed person are not attended to by the manpower service provider the deployed person can place their grievance before a joint committee consisting of a representative of the Zilla Parishad, Mayurbhanj office concerned and authorize representative of the manpower service provider.
- 13.The Zilla Parishad, Mayurbhanj shall be not be responsible for any financial loss or any injury to any person deployed by the manpower service provider in the course of their performing the functions/duties, or for payment towards any compensation.
- 14. The persons deployed by the manpower service provider shall not claim nor shall be entitled to pay, perks and other facilities admissible to regular/confirmed employees during the currency or after expiry of the Agreement.

- 15.In case of termination of this agreement in its expiry or otherwise the persons deployed by the manpower service provider shall not be entitled to and shall have no claim for any absorption in regular or other capacity.
- 16.The person deployed shall not claim any benefit or compensation or regularization of deployment with office under the provision of rules and acts.

  Undertaking from the person deployed to this effect shall be required to be submitted by the manpower service provider.
- 17. The manpower service provider must be registered with the concerned Govt. Authorities i.e. Labour Commissioner, provident fund authorities, Employees State Insurance Corporation etc. and a copy of the registered should be submitted. The manpower service provider shall comply with all the legal requirements for obtaining license under contract labour (regulations and abolition) act, 1970 if any at his own part of cost.
- 18. The manpower service provider shall provide a substitute well in advance if there occurs any probability of the person leaving the job due to his/her own personal reasons. The payment in respect of the overlapping period of the substitute shall be the responsibility of the manpower service provider. The manpower service provider shall be responsible for contributions towards Provident Fund and Employees state insurance, whatever applicable.
- 19. The person deployed by the manpower service provider should have good police records and no criminal case should be pending against them.
- 20. The person deployed should be polite, cordial and efficient while handling the assigned work and their actions should promote good will and enhance the image of the Zilla Parishad, Mayurbhanj of office concerned. The manpower service provider shall be responsible for any act of indiscipline on the part of the person deployed.
- 21. The person deployed shall during the course of their work be privy to certain qualified documents and information which they are not supposed to divulge to third parties. In view of this they shall be required to take oath of confidentiality and breach of this condition shall make the manpower service provider as well as the person deployed liable for penal action under the application laws besides, action for breach of contract.



- 22. The manpower service provider shall be responsible for compliance of all statutory provisions relating to minimum wages payable to different types of worker in respect of the persons deployed by it in the Zilla Parishad, Mayurbhanj or office concerned shall have no liabilities in this regard.
- 23.The manpower service provider shall also be liable for depositing all taxes, levies, cess, etc. on account of service rendered by it to the Zilla Parishad, Mayurbhanj or office concerned to the concerned tax collection authorities from time to time, as per the rules and regulations in the matter. Attested Xerox copy of such documents shall be furnished to the Zilla Parishad, Mayurbhanj or office concerned.
- 24. The manpower service provider shall maintain all statutory registers under the law and shall produce the same on demand, to the authority of the Zilla Parishad, Mayurbhanj of office concerned or any other authority under law.
- 25. The tax deduction at source(T.D.S) shall be done as per the provision as per the income tax act/rule, as amended from the time to time and certificate to this effect shall be provided by the Zilla Parishad, Mayurbhanj or office concerned.
- 26.In case the manpower service provider fails to comply with any liability under appropriate law and as result thereof, the Zilla Parishad, Mayurbhanj to the office concerned is put to any loss/obligation, monitory or otherwise, the Zilla Parishad, Mayurbhanj to the office concerned will be entailed to get itself reimbursed out of the outstanding bills or the performance security deposit of the manpower service provider to the extent to the loss or obligation in monetary terms.
- 27. Agreement is liable to terminated because of non-performance deviation of terms and condition of contract, non-payment of remuneration of employed person and non-payment of statutory dues. The Zilla Parishad, Mayurbhanj of office concerned will have no liability towards non-payment of remuneration to the person employed by the manpower service provider and the outstanding statutory dues of the service provider to statutory authorities. If any loss or damage is caused to the Zilla Parishad, Mayurbhanj or office concerned by the person deployed, the same will be recovered from the unpaid bills or adjusted from the performance security deposit.



- 28.In case of breach of any terms and conditions attached to the agreement, the performance security deposit of the manpower service provider shall be liable to be forfeited besides annulment of the agreement.
- 29. The manpower service provider shall raised the bill in triplicate along with attendance sheet duly verified by the Zilla Parishad, Mayurbhanj or Office concerned in respect of the persons deployed and submit the same to the prescribed authority in the first week of the succeeding month. As per as possible the payment will be released by the second week of the succeeding month.
- 30. The claim in bills regarding employees state insurance, provident fund, service tax, etc. should necessarily accompanied with documentary proof pertaining to the concerned bill month. A requisite portion of the bill or whole of the bill amount shall be held up till such proof is furnished, at the discretion of the Zilla Parishad, Mayurbhanj or office concerned.
- 31. The amount of penalty calculated @Rs.100/- per day on account of delay, if any in providing a suitable substitute for the period beyond three working days by manpower service provider shall be deducted from its monthly bills in the succeeding month.
- 32. The authority reserve the right to withdraw or relax any of the terms and conditions mentioned above so as to overcome the problem encountered at a later stage.
- 33.In the event of any dispute arising in respect of the clauses of the agreement the same shall be resolved through negotiation. Alternatively the dispute shall be refer to the next higher authority for controlling officer for his decision and the same shall be binding on all parties.
- 34.All disputes shall be under the jurisdiction of the court at the place where the headquarters of the authority, who has executed the agreement, is located.
