The sealed Tender Paper will be received on working days till **12.00 Noon** from date. **10/04/2023** to **26/04/2023**. The same should be submitted either through registered/ speed post addressing to the BDO, Gopabandhunagar or same may be dropped in the tender box kept in the Block office, Gopabandhunagar during working hour. No tender paper will be received by hand service. The sealed envelope shall be superscripted as "Tender Paper" <Name of the Project & Sl. No. > The undersigned will not be held responsible for any delay in the postal service. The Last date of receipt of the bid documents is till **26/04/2023 up to 12.00 Noon**.
- Cost of Tender Paper:** Bid must be accompanied by a Demand Draft of Rs.6000/- in favour of Block Development Officer, Gopabandhunagar payable at Khunta towards Cost of tender paper (non-refundable).

- 3 **Earnest Money Deposit (EMD)** :The EMD as **mentioned in col.5** is to be deposited in shape of NSC/KVP/POTD/ Fixed Deposit of any Nationalized Bank duly pledged in favour of the Block Development Officer, Gopabandhunagar. Payable at Khunta. Tenders not accompanied with EMD shall be liable for rejection. The Earnest Money deposited will be refunded to the unsuccessful tenderers on application as per the terms and conditions as laid down in OPWD Code and the same will be retained in case of the successful tenderers and will not carry any interest.
- 4 **Date of Opening of the Tender paper:** The Tender Papers/Bids will be opened on **11.00 AM** on date **27/04/2023** in presence of the bidders or their authorized representatives and Block Tender Committee in the Block Conference Hall.
- 6 The following documents should be furnished along with the tender paper failing which the tender is liable for rejection.
  - a. Original Demand Draft of Rs.6000/- in favour of Block Development Officer, Gopabandhunagar payable at Khunta towards Cost of tender paper (non-refundable)
  - b. EMD duly pledged in favour of the BDO, Gopabandhunagar.
  - c. Self Attested copy of the contractor valid registration certificate/ License.
  - d. Self Attested copy of PAN CARD.
  - e. Self Attested copy of valid GST registration Certificate.
  - f. Attested copy of caste certificate for SC/ST contractor desirous of availing preference, if applicable
  - g. Self Attested Copy of PH Certificate for differently-abled Contractors, if Applicable
  - h. Affidavit for Engineer contractor, if any
  - i. Signed copy of DTCN and price bid duly filled in and signed by the tenderer.
  - j. An affidavit regarding authenticity of the credentials.
- 7 The EMD amount will be forfeited, if the Tenderer backs out from the offer of acceptance of Tender by the competent authority.
- 8 The Tenderer has to show all required original documents at the time of opening of the tender for verification.
- 9 Joint Stock Companies/ Joint Ventures are not allowed to participate in the tender process.
- 10 If the rate quoted by the Tenderers is found to be same, Tender Committee will take the final decision.
- 11 Excess bid amount quoted by the bidder, if any, in respect of any work shall not be accepted.
- 12 All the tenders where rate quoted is more than 14.99 % less than the scheduled rate will be rejected.
- 13 The tender is to be submitted in sealed envelope with all documents described and required as per the relevant clauses of the DTCN and Special Conditions if any.
- 14 The Engineer Contractor seeking exemption of EMD is to be enclosed an affidavit regarding the number of tenders they have participated with exemption of E.M.D prior to the date during the current financial year 2023-24. Also she/he will have to produce his/her original licence at the time of opening, so that the authority will enter the same in the license which is mandatory.
- 15 ST/SC and differently abled Contractors can avail facilities as per Govt. circular.



- 16 Additional performance Security deposit shall be obtained from the bidder when the bid amount is less than the estimated cost put to tenders as per Works Department Letter No.4710 dated 21.04.2022 . In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount as Additional performance Security (APS )in shape of Demand Draft/ Term Deposit Receipt pledged in favour of Block Development Officer, Gopabandhunagar within Seven days, otherwise the bid shall be cancelled and the EMD shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder.

- 17 All bids received will remain valid for a period of 90days from the date of receipt of bids or till the date of drawl of Agreement whichever is earlier and validity of bids can also be extended if agreed by the bidder and the Department/Office.
- 18 If the L-1 bidder does not turn up for agreement after finalization of tender, than she/he shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case L-2 bidder if fulfill, other required criteria would be called for drawing agreement for execution of work subject to the condition, that L-2 bidder negotiate at par with the rate quoted by the L-1 bidder otherwise tender will be Cancelled.
- 19 The rates to be quoted by the contractor shall be excluding GST. The implementation of the GST rules by the Govt. of Odisha is to be accepted by the bidder from time to time.
- 20 The authority Reserves the rights to reject or cancel any or all the Tender without assigning any reason thereof.
