- 4. Date of Opening of the tender Paper: The Bids will open on Dt. 02.05.2023 at 11.00 A.M.at the Conference Hall, Panchayat Samiti, Raruan, MAYURBHANJ in the presence of the bidders who wish to attend. If the office happens to be closed (holiday) on the date of receipt/opening of the bids as specified, the bids will be received/opened on the next working day at the same time and venue without further notice. However, date of tender paper opening may be postponed as per the convenience of the authority by intimating all the concerned tenderers through notice affixing to notice board at Office of the Block Development Officer, Raruan, Mayurbhanj.
- 5. Additional Performance Security Deposit: Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tenderas per works deptt. Letter No. 4710 .dt12.04.2022 In such an event, only the successful bidder who has quoted less bid price/rates than the estimate cost put to tender shall have to furnish the exact amount of differential cost i.e., Estimated cost put to tender minus the quoted amount as additional performance security(APS) in shape of N.S.C/K.V.P/ Postal time deposit pass book/Term Deposit receipt duly pledged in favour of BDO, Raruan within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder.

- 6. The following Documents should be furnished with the tender paper failing which the tender is liable for Rejection.
 - A) EMD Pledged in favour of BDO Raruan.
 - B) Attested copy of valid Contractor Registration Certificate.
 - C) Attested copy of valid Pan Card &GST filling reports for the month of November & December 2022 other wise Tender will be rejected.
 - D) SC/ST Contractors submit original Affidavit in support of cast certificate and attested copy Of Cast certificate.
 - E) Bank Draft towards cost of Tender paper in favour of BDO, Raruan.
- 7. Engineering Contractors desiring to avail the exemption facility of EMD should submit an original affidavit as regards, the fact of availing award of work without submission of EMD/ISD during the current financial year. He should also produce original contract licence at the time of opening of tender document to make necessary entry to that effect as such facilities are limited to three participation in tender during a financial year. Otherwise, their tender will be liable for rejection,
- 8. The SC/ST Contractors desirous of availing preference should submit an original affidavit in support of caste certificate and attested copy of caste certificate. Otherwise their tender will be liable for rejection.
