Terms and condition

- 1. The Tender Paper can be obtained from Office of the Panchayat Samiti, Karanjia on payment of Cost of the tender paper (non refundable) in shape of cash.
- 2. The Tender Paper will be sold from date 31.05.2023 to 06.06.2023 on working days only from 7.00AM to 12.00 PM in the office of the Panchayat Samiti, Karanjia.

- 3. The sealed tender paper will be received on official working days only from 7.00AM to 1.00PM from dtd 31.05.2023 to 06.06.2023. The Tender paper shall be dropped in the tender box which is kept in the Block Office, Karanjia during working hour. The sealed envelope shall be superscripted as "Tender Paper" properly (Name of the Project & Identification No) falling which the tender will be liable for rejection. The undersigned will not be held responsible for any delay in the postal service.
- 4. The Tender Paper will be opened on date 07.06.2023 at 10.00 AM in presence of the bidders or their authorized representatives if they choose to be present and Block tender Committee in the Karanjia Block Conference Hall.
- 5. Bid Security declaration must be accompanied with the bid document (O.M. No.5984/W Dtd.27.04.2021 of works Department Govt. of Odisha). <u>Tenders not accompanied with bid security declaration shall be liable for rejection</u>.
- 6. EMD as mentioned in col.5 is to be deposited in shape of NSC/KVP/POTD/Fixed Deposit of any Nationalized Bank duly pledged in favour of the Block Development Officer, Karanjia & Payable at SBI Karanjia. Tenders not accompanied with EMD shall be liable for rejection. The deposited Earnest Money will be refunded to the unsuccessful tenderers on application as per the terms and conditions as laid down in OPWD Code and the same will be retained in case of the successful tenderer which will carry no interest.
- 7. The following documents should be furnished in the following order along with the tender paper failing which the tender is liable for rejection.
 - a. Original Money receipt of DTCN (Tender Paper).
 - b. EMD duly pledged in favour of the BDO, Karanjia.
 - c. Self Attested copy of the contractor valid registration certificate/ License.
 - d. Self Attested copy of PAN Card/ Labour License/
 - e. Self Attested copy of valid GST registration Certificate.
 - f. Attested copy of caste certificate for SC/ST contractor desirous of availing preference, if applicable.
 - g. Self Attested Copy of PH Certificate for differently abled Contractors, if tenderer.
 - h. Affidavit for Engineer contractor, if any
 - i. Signed copy of DTCN and price bid duly filled in and signed by the tenderer.
 - j. An affidavit regarding authenticity of the credentials.
 - k. Bid Security declaration
 - 1. GST clearance Certificate up to the month of APRIL-2023
 - m. Any other as specified in the Tender Notice.
- 8. The EMD amount will be forfeited, if the Tenderer turn down the offer of acceptance of Tender by the competent authority.
- The Tenderer has to show all required original documents at the time of opening of the tender for verification. The tenderers should carry all original documents during opening of the tender for verification purpose.
- 10. The contractor must have executed or have authority to execute similar nature of works—and financial turn over in last three years. The above information should be certified—by the concerned authority not below the rank of BDO/ Executive Engineer. This certificate—must be submitted along with application failing which the bid will be cancelled.
- 11. Joint Venture Consortium agreements are not allowed to participate in the Tender process.
- 12. If the rate quoted by the Tenderers is found to be same, Tender Committee will take the final decision and further course of action.
- 13. Excess bid amount quoted by the bidder, if any, in respect of any work shall not be accepted.

- 14. If the rate quoted by the bidder is exactly 15% less or more than 15% less of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders / their authorized representatives and members of the tender committee will remain present.
- 15. The tender is to be submitted in sealed envelope with all documents described and required as per the relevant clauses of the DTCN and Special Conditions if any.
- 16. The Engineer Contractor seeking exemption of EMD has to enclose an affidavit regarding the number of tenders they have participated with exemption of E.M.D.
- 17. ST/SC and differently abled Contractors can avail facilities as per Govt. circular.
- 18. The bidder shall have to furnish an affidavit along with the bid regarding the authenticity of the bid documents falling which the bid will be rejected.
- 19. Additional performance Security deposit shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated Draft/Term Deposit Receipt pledged in favour of Block Development Officer, Karanjia within Seven days, otherwise the bid shall be cancelled and the EMD shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder.
- 20. All bids received with remain value for a period of 90 days from the date of receipt of bids or till the date of drawl of Agreement whichever is earlier and validity of bids can also be extended if agreed by the bidder and the Department/ Office.
- 21. If the L-1 bidder does not turn up for agreement after finalization of tender within Seven days of declaring successful bidder, then she/he shall be debarred from participation in bidding for three years and action will be taken to make blacklisted the bidder. In that case L-2 bidder if fulfill, other required criteria would be called for drawing agreement for execution of work subject to the condition, that L-2 bidder negotiate at par with the rate quoted by the L-1 bidder otherwise tender will be Cancelled.
- 22. The rates to be quoted by the contractor should be excluding GST. The implementation of the GST rules by the Govt. of Odisha is to be accepted by the bidder at any point of time.
- 23. The authority Reserves the rights to reject or cancel any or all the Tenders without assigning any reason thereof at any point of time.
- 24. Application from the defaulters / previously disqualified bidders will not be allowed/entertained.

25. Payment of works bill will be made on receipt/ availability of allotment under the relevant scheme.
