- 3. The sealed Tender paper will be received on working days till 01.00 PM of date 13.07.2023. The same should be submitted either through registered /speed post addressing to the BDO, Suliapada or same may be dropped in the tender box kept in the Block office, Suliapada during working hour. The sealed envelope shall be super scribed as "Tender Paper". The undersigned will not be held responsible for any delay in the postal service.
- 4. The Tender paper will be opened at 03.00 PM on date **13.07.2023 in presence of the bidders or** their authorised representatives and Block tender committee.
- 5. The EMD is to be deposited in shape of NSC/KVP/POTD/deposit of any Nationalise Bank duly pledged in favour of the Block Devlopment Officer, Suliapada.
- 6. The following documents should be furnished along with the tender paper failing which the tender is liable for rejection.
  - a. EMD duly pledged in favour of the BDO, Suliapada.
  - b. Attested copy of the Contractor registration certificate.
  - c . Attested copy of PAN CARD /labour Lisence/GST clearance certificate.
  - d. Money receipt of DTCN (Tender Paper) shall be enclosed in original.
  - e. Attested copy of Cast certificate for SC/ST Contractor desirous of availing preference.
  - f. The Engineering Contractor desirous of availing exemption of EMD should submit an affidavit to the effect that he has not availed exemption of EMD facility more than three times in the current F.Y.
- 7. The Schedule cast/Schedule Tribe/physically handicapped Contractors desirous to avail the exemption of EMD and price preference (as applicable), should mention this in the Affidavit.
- 8. If the less rate quoted by the tenderer is more than 10% and within 15% the additional performance security is to be deposited in shape of NSC/KVP/Bank Draft /banker Cheque which

are duly pledged in favour of the BDO, Suliapada at the time of dropping of tender paper as per revised codal provision i.e. Amended 2013(Vide O.M.12366/W, dated 08/11/2013) of OPWD code modified vide office Memorandum No.5288/W, dated 04/05/2016 of The Govt. in Works Department.

- 9. The EMD amount will be forfeited if the Tenderer backs out from the offer of acceptance of Tender by the competent authority.
- 10. The Tenderer has to show all required original documents at the time of opening of the tender for verification.
- 11. The Contractor must have executed similar nature of works and financial turn over in last three years. The tenderers are required to submit the list of T&P possessed, list of works executed and successfully completed the Civil works during last three years. The above information should be certified by the concerned authority not below the rank of BDO/Executive Engineer.
- 12. An affidavit in support of the authority of document including no relation certificate and detail work programme should be attached with the tender paper.

13. If the rate quoted by The Tenderers is found to be same, Tender Committee will decide th Tender.

14. Excess bid amount quoted by the bidder, if any, in respect of any work shall not be accepted. authority deserves all right to reject or cancel any or all Tender without assigning any reason thereof.
