The Block Development officer, Karanjia Dist-Mayurbhanj on behalf of the Govt. of Odisha invite sealed tender in percentage (%) basis from registered contractors of Odisha PWD/WR/RWD/NH/MI/CPWD & PH for following works in conformity with the detail tender call notice (DTCN).The proof of registration from the appropriate authority shall be enclosed along with tender papers.

2. The tender papers shall submit for the following works.

Terms and condition

1. The Tender Paper can be obtained from the Block Development Officer, Karanjia on payment of Cost of the tender paper (non refundable in shape of cash).
2. The Tender Paper will be sold from date **25.07.2023** to **31.07.2023** on working days only from **10 AM to 4.00 PM** in the office of the Panchayat Samiti, Karanjia.
3. The sealed Tender Paper will be received on working days till **5.30 PM** from date **25.07.2023** to **31.07.2023** The same should may be dropped in the tender box kept in the Block Office, Karanjia during working hour. The sealed envelope shall be superscripted as "Tender Paper" <Name of the Project & Sl. No.,
4. The Tender Paper will be opened on date **01.08.2023 at 11AM** in presence of the bidders or their authorized representatives and Block tender Committee in the Block Conference Hall.
5. EMD as mentioned in col.5 is to be deposited in shape of NSC/KVP/POTD/Fixed Deposit of any Naionalised Bank duly pledged in favour of the Block Development Officer, Karanjia. Payable at Karanjia. Tenders not accompanied with EMD shall be liable for rejection. The Earnest money deposited will be refunded to the unsuccessful tenderers on application as per the terms and conditions as laid down in OPWD Code and the same will be retained in case of the successful tenderers and will not carry any interest.
6. The following documents should be furnished along with the tender paper failing which the tender is liable for rejection.
 - a. Original Money receipt of DTCN (Tender Paper).
 - b. EMD duly pledged in favour of the BDO, Karanjia.
 - c. Self Attested copy of the contractor valid registration certificate/ License.
 - d. Self Attested copy of PAN Card/ Labour License/ GST clearance Certificate.
 - e. Self Attested copy of valid GST registration Certificate.
 - f. Attested copy of caste certificate for SC/ST contractor desirous of availing preference, if applicable.
 - g. Self Attested Copy of PH Certificate for differently abled Contractors, if tenderer.
 - h. Affidavit for Engineer contractor, if any
 - i. Signed copy of DTCN and price bid duly filled in and signed by the tenderer.
 - j. An affidavit regarding authenticity of the credentials.
7. The EMD amount will be forfeited, if the Tenderer backs out from the offer of acceptance of Tender by the competent authority.



8. The Tenderer has to show all required original documents at the time of opening of the tender for verification.
9. Joint Venture Consortium agreements are not allowed to participate in the Tender process.
10. If the rate quoted by the Tenderers is found to be same, Tender Committee will take the final decision.
11. Excess bid amount quoted by the bidder, if any, in respect of any work shall not be accepted.
12. If the rate quoted by the bidder is exactly 15% less or more than 15% less of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders / their authorized representatives and members of the tender committee will remain present.
13. The tender is to be submitted in sealed envelope with all documents described and required as per the relevant clauses of the DTCN and Special Conditions if any.
14. The Engineer Contractor seeking exemption of EMD has to enclose an affidavit regarding the number of tenders they have participated with exemption of E.M.D prior to the date during the current financial year 2023-24. Also she/he will have to produce his/her original license at the time of opening, so that the authority will enter the same in the license which is mandatory.
15. ST/SC and differently abled Contractors can avail facilities as per Govt. circular.
16. Additional performance Security deposit shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated Draft/Term Deposit Receipt pledged in favour of Block Development Officer, Karanjia within **Seven days**, otherwise the bid shall be cancelled and the EMD shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder.
17. All bids received with remain value for a period of 90 days from the date of receipt of bids or till the date of drawl of Agreement whichever is earlier and validity of bids can also be extended if agreed by the bidder and the Department/ Office.




18. If the L-1 bidder does not turn up for agreement after finalization of tender, than she/he shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case L-2 bidder if fulfill, other required criteria would be called for drawing agreement for execution of work subject to the condition, that L-2 bidder negotiate at par with the rate quoted by the L-1 bidder otherwise tender will be Cancelled.
19. The rates to be quoted by the contractor shall be excluding GST. The implementation of the GST rules by the Govt. of Odisha is to be accepted by the bidder from time to time.
20. The authority Reserves the rights to reject or cancel any or all the Tender without assigning any reason thereof at any point of time.




