

- (2) The sealed cover super scribed as "Sealed tender paper of condemned vehicle bearing No. OR-05-G-6495 should be sent addressing to the Deputy Director, Consolidation of Holdings, Baripada At/- Budhikhamari, Post/- Bhanjpur, Dist/- Mayurbhanj, Baripada Pin - 757002 by registered post / speed post or to be dropped in the sealed tender box kept in the office chamber of the Deputy Director, CH., Baripada before 3.00 P.M. on dt. 27/07/2018 / .The entire tender received within 15 days from date of announcement and shall be opened at 4.00 PM on the same day i.e. 27/07/2018 / in presence of tenders or their authorized agent in the chambers of the Addl. District Magistrate, Mayurbhanj-Cum-Deputy Director, Consolidation of Holdings, Baripada
- (3) The vehicle shall be kept in the O/O DDCH, Baripada campus which may be inspected during office hour on any working day.
- (4) The competitors shall be required to deposit Earnest Money amounting to Rs.1,000/- (Rupees One thousand) Only in shape of Bank Draft in favour of DDCH, Baripada payable to at SBI Baripada which shall be refunded on application after disposal of the vehicle.
- (5) The highest offered price above the up set price may be approved by the competent Authority. The highest tenders shall be deposit 25% of the amount immediately after announcement and rest amount within 7 days of the approval of the offer..
- (6) On failure to make payment as aforesaid, the Earnest money shall be forfeited and the vehicle may put to fresh tender or the second highest bidder above upset price may be considered.
- (7) The vehicle shall not be delivered to the party until full payment is made and compliance with the requisite formalities. Tools, equipment's and spare parts shall not be delivered with vehicle.
- (8) The successful bidders shall take steps for charge of ownership in his/her favour consulting the local Road Transport Authority and compliance of all necessary official formalitis.
