

The Collector –cum-Ex-Officio Chief Executive Officer, Special Development Council, Mayurbhanj on behalf of Governor of Odisha inviting Annual Rate Contract in **OFF-LINE** mode from eligible Manufacturers/Authorized Suppliers for supply of Musical Instruments 456 Tribal cultural clubs/dance troupes and Costumes for 52 tribal dance troupes in respect of FOUR Integrated Tribal Development Agency, such as, Baripada, Udala/kaptipada, Karanjia & Rairangpur vduring the financial year 2018-19 under Special Development Council Funds. The Approximate requirement of quantity and the type of costume and Musical Instruments for 12 different Tribal Dance Group will be as per the list enclosed herewith separately at Annexure-I. Like-wise, 456 sets of Musical Instruments and 52 sets of costumes will be required for different tribal dance group, which may vary basing on the actual requirement at the time of orders. The bidders are required to quote their rate in the enclosed Financial Bid (Annexure-II) separately for each group in the said Format & shall bring samples of the different items on the day of opening of tender.

The bid documents are available in the Mayurbhanj District Official website of NIC [www.mayurbhanj.nic.in](http://www.mayurbhanj.nic.in) and can be downloaded from 11.00 A.M of Dt. 10.07.2018 to Dt. 25.07.2018 up to 5.00 P.M. The last date and time of submission/receipt of Bid as per contract date through Registered Postal delay cannot be considered .

#### **MUSICAL INSTRUMENTS & COSTUMES:**

The musical instruments and costumes as per list at Annexure-I should be of good quality. Priority will be given to the bidders considering the quality of materials and price quoted thereof. The Approximate requirement of quantity and the type of costume and Musical Instruments for 12 different Tribal Dance Group will be as per the list enclosed herewith separately at Annexure-II. Like-wise, 456 sets of Musical Instruments and 52 sets of costumes will be required for different tribal dance group/cultural clubs, which may vary basing on the actual requirement at the time of orders. The requirement may exceed or decrease depending on the actual requirement and orders will be placed accordingly from time to time during the period of Annual Rate Contract. The bidders are required to quote their rate item-wise / unit-wise in the enclosed prescribed Format of Financial Bid separately for group at Annexure-II/1 to Annexure-II/6.

#### **Manufacturer/Supplier/Proprietors:**

A person, group, or company that owns or runs a manufacturing plant.

A person, group, or company that manufactures/ Authorized Supplier.

### **Eligibility Criteria:**

- 1.1 All Manufacturers/ Suppliers/ Proprietors dealing with supply of Musical Instruments and costumes for tribal.
- 1.2 Preference shall be given to the manufactures/ Suppliers/ Proprietors of Mayurbhanj district.
- 1.3 The Supplier should have valid Income Tax(PAN)/Sales Tax Registration Certificate.
- 1.4 The Financial bids (Annexure-II) should also be accompanied with tender document.
- 1.5 All the terms & conditions of DTCN must be fulfilled by the bidder and the required amount towards cost of Tender Paper & EMD must be submitted in shape Draft along with tender documents.

### **2. Scope of work:**

- 2.1 The broad scope of work would be design, supply and transportation of musical instruments and costume for tribal to blocks/Register Club/ Community Centre point by whom Supply Order are to be placed.
- 2.2 Storage facility of the items to be supplied should be provided by the Supplier for inspection at intermediate points for facilitating the process.
- 2.3 The Agencies shall have to supply the items to the Nodal PA, ITDA, Baripada as per the work order. Intended Suppliers are advised to collect all necessary information before hand about approach road to the village, distance and mode of transportation etc, before submitting the Annual Rate Contract.
- 2.4 Proper storage of musical instruments and costumes shall be the responsibility of the Suppliers. The name of Register Club/ Community Centre will be provided with the work order. In some cases, actual number of items to be supplied may vary to some extent, hence suppliers are required to seek conformation in this regard from Nodal PA, ITDA, Baripada prior to dispatch of musical instruments and costumes.
- 2.5 After supply of the musical instrument/ costumes to Nodal PA, ITDA, Baripada in the specific locations as per instruction of the Chairman, SDC, Mayurbhanj/ District Cultural Officer/ Concerned PA, ITDAs/ Authorized Officer. The Suppliers shall obtain acknowledgement from the concerned ITDAs.
- 2.6 The date of commencement of supply shall be reckoned as the date of issue of Supply Order.
- 2.7 All necessary conditions as further outline in the subsequent sections of this document are to be followed.

### **3. Instructions to Bidders:**

- 3.1 Bidders must submit their bid through proper means.
- 3.2 Bidder must be submitted in English language only.
- 3.3 Incomplete, telegraphic or conditional bids shall not be accepted.
- 3.4 Prices quoted must be firm and fixed. No price variation / escalation shall be
- 3.5 The Bidders/ authorized Agent must sign at the bottom of each page bid documents at the time of submission in token of unconditional acceptance of the departmental terms and conditions, technical specifications etc.
- 3.6 Copy of IT returns Statement / Valid GSTN/Copy of PAN card etc. Duly attested must be submitted along with the bid.
- 3.7 Devastation in terms and condition, Inspection clause etc. Would not be accepted under normal conditions. However, under exceptional situation the same may be considered at the discretion of authority.

- 3.8 The quantities of materials to be purchased are subject to alteration without any notice.
- 3.9 Since timely supplies of materials are of paramount importance, requests for extension of time shall not be entertained.
- 3.10 Canvassing in any manner shall not be entertained will be viewed seriously leading to rejection of the bid.
- 3.11 All essential supplementing documents should be signed in case of need for verification, originals should be produced.
- 3.12 Earnest money/ Tender Paper Cost must be deposited in shape of Demand Draft to be drawn in favour of the **Project Administrator, ITDA, Baripada Mayurbhanj** payable at **Baripada Mayurbhanj** from any Scheduled Bank. **Bids without E.M.D and Bid Cost will be rejected.**
- 3.13 **The last date of receipt of the bid through OFF-LINE mode i.e. by Registered Post/ Speed Post (Post Office only) is up to 5.00 P.M of 25.07.2018, after which if any tender documents to be received will be rejected.**
- 3.14 **The bid documents received in OFF-LINE mode through Registered post/ Speed Posts by the date line shall be opened on 26.07.2018 at 03.00 PM** in the office chamber of the Collector, Mayurbhanj in presence of the bidders or their authorized representatives, who may like to be present at the time of opening.
- 3.15 The bidders during supply of the materials are required to fix with logo of Special Development Council to be supplied by ITDA, Baripada Mayurbhanj to the selected suppliers, after the tender is finalized.
- 3.16 Power of attorney to sign the agreement on behalf of bidders & partnership deed articles, if any, should be along with original bid documents.
- 3.17 Notice inviting tender, bid documents, prescribed price bid, terms & conditions will form the part of the tender.
- 3.18 In case of supply of any defective material or substandard material, the materials will be rejected & it will be responsibility of the supplier for taking back & replacing the rejected materials at their own cost. In case of non-lifting of such rejected materials within a reasonable time offered by the office, it will have the right to suitably dispose of the same and forfeit the amount.
- 3.19 The supplied materials should be strictly complied with the specifications as mentioned in the bid; otherwise the material would be liable for rejection.
- 3.20 Bidders may in their own interest visit the sites or undertake field enquiry of the proposed places before submitting bids. SDC, Mayurbhanj will not be responsible for any incidental or consequential losses of the firms during supply of materials.
- 3.21 All bids received will remain valid for a period (30 days) as specified in the contract Data after the deadline date for submission of bids and validity of bids can also be extended if to by the bidder and the Department.

(4) **Procedure for opening of Tender:**

(A) The procedure of opening of the bid shall be as under

- i) The Bid documents along with Financial bid shall be opened by the Tender Committee as per the date, time and venue mentioned in the "Tender Call Notice & DTCN", in presence of tenderers who choose to be present. The financial suitability of offers will be examined in detail consideration documentation submitted by the Supplier also.
- ii) All bidders shall essentially quote their rate in the Financial Bid Format (Annexure-II).

(5) **Acceptance/ Rejection of the bid documents:**

Collector-cum-Ex-officio Chief Executive Officer, Special Development Council, Mayurbhanj reserves the right to;

- i) Rejected or accept any or all bids without assigning any reason thereof.
- ii) To split the quantities against the bid on more than one firm for the same items.
- iii) Alter or delete any of the terms and conditions mentions in this bid documents during the process of tender till finalization, for which, No reason will be assigned by SDC for this and the same will be binding on the bidders.

6. **Earnest Money Deposit:**

- 6.1 The earnest money deposited (EMD) is to be paid through Demand Draft issued from any Scheduled Bank in favour of the Project Administrator, Mayurbhanj and should be enclosed with the bid documents.
- 6.2 Unsuccessful Bidder's EMD will be discharged/ returned as promptly as possible within thirty (30) days after the issuance of work order to successful bidder.

**The bid security may be forfeited:**

If a Bidder :

- i) Withdraws its bid during the period of bid validity specified by the Bidder on the Bid Form.
- ii) In case a successful Bidder fails to sign the Contract within the specified period.


7. **Payment Terms:**

Payment under normal circumstances will be done as detailed below;

- i) The payment will be released by the Nodal PA, ITDA, Baripada only after supply of the intended materials in good condition, on production of necessary bill/ vouchers in this regard by Supplier. The Suppliers are also required to furnish a certificate to that effect regarding handing over of the materials.

8. **TERMS & CONDITIONS:**

- (a) The Bid documents shall be submitted by Register post/ Speed post only in the address of project Administrator, ITDA, Baripada Mayurbhanj, At/Po-Baripada, district-Mayurbhanj, PIN-757002, Odisha. Conditional tenders without EMD shall be rejected.
  - (b) The Rate quoted should be on the basis of for destinations anywhere in Mayurbhanj district. Prices to be quoted in Financial Bid will be with all applicable taxes. To Quoted rate shall be valid for one year from the date of opening of tender as this is Annual Rate Contract.
9. The bidders from Mayurbhanj district should be given priority during finalization of tender.
10. PA,ITDA, Baripada/ Chairman, Special Development Council, Mayurbhanj reserves the right to split the work order on the lowest quoted rates to one or more than one qualified bidders other than lowest-1 for early of materials or any other reasons, if requires. The decision of Chairman, SDC, Mayurbhanj regarding quantity will be final and binding on selected bidders in this case.
11. The materials shall be supplied at the specified site after confirming from Concerned PA, ITDAs of Mayurbhanj District.
12. The work order(s) shall be placed depending upon the requirement of the agency from time to time within the validity period of tender.
13. All disputes relating to this work shall be subject to the jurisdiction of SDC, Mayurbhanj district headquarters and Collector, Mayurbhanj shall be the sole arbitrator.






