The samples of articles approved by the committee as per tender programme on 05.11.18 at Sub-Collector Office, Baripada will be submitted to this Project Office of the undersigned for subsequent verification. The quotationers or their representatives are requested to be present at 05 PM on 03.11.18 at the time of closing of the Tender box in this office.

The undersigned reserved the right to reject any or all quotations without assigning any reason thereof.



The articles are required to be delivered on the office of ICDS Project, SULIAPADA within 10 days from the date of receipt of supply orders.

TERMS AND CONDITIONS :

- 1 The quotations shall be received by the undersigned through registered post with AD or by hand in sealed packets during office hours i.e from 20.10.18 to 03.11.18 (10 AM to 5 PM) and the same will be opened on 05.11.18 at 11 AM in the office of the Sub-Collector, Baripada in the presence of the members of tender committee and the quotationers or their authorized agents.
- 2 No quotation will be entertained after the stipulated date and time.
- 3 The quotationer has to quote single rate of the articles in the scheduled prescribed for the purpose inclusive of all taxes, transporting cost and other incidental charges, if any, and delivery should be made in the ICDS Project Office, SULIAPADA.

- 4 The quotationer has to submit following documents :
- i- Firm Registration Certificate
 - ii- Registration Certificate of GST
 - iii- Up to date GST Clearance Certificate
 - iv- Copy of PAN card
 - v- Last one year IT Returns (FY 2017-18)
 - vi- Bank Account Number (Cancelled Cheque)
- 5 The quotationer shall deposit security money of Rs 5,000/- (Rupees Five thousand) only in the Office of the undersigned and attach the money receipt with the quotation. The security money of the unsuccessful quotationer will be refunded after finalization of the tender process on proper applications.
- 6 The quotation once submitted will not be returned of the exchange.
- 7 The quotationers are required to produce the samples before the purchase committee for finalisation of the quotations on 05.11.18 at 11 AM.
- 8 The successful quotationers shall supply all the articles within 10 (ten) days from the date of receipt of the supply order, failing which, the supply order will be cancelled and simultaneously the security money will be forfeited.
- 9 The rejected materials not matching with the approved sample shall be replaced by the suppliers at their own cost at the time of delivery.
- 10 Payment will be made after receipt of all items as per supply order in the approved rate and quantity on proper verification by the undersigned. No interest can be charged by the quotationers for deferred payment, if any.
- 11 Non-fulfillment of the aforesaid terms and conditions will lead to non-acceptance of quotation.
- 12 The quotationers are required to submit the copy of the 1st page of Bank Account.
- 13 The CDPO, SULIAPADA reserves the right to cancel any or all the quotations without assigning any reasons thereof and may accept the higher rate quoted by any quotationer considering the quality of the articles.
