3. Bids must be accompanied by E.M.D. of the amount specified for the work under column-6 in the table, E.M.D. shall have to be in any one of the forms such as NSC/ KVP/ POTD/ POSB/ Deposit receipt of scheduled commercial Bank duly pledged in favour of Chief District Medical and Public Health Officer, Mayurbhanj, Baripada. The Bids must be accompanied by copy of valid GST registration Certificate, Pan Card, Contractor Registration Certificate and affidavit regarding authentication of documents etc.

The Sale of the Bid document will start on 27.12.2018 to 05.01.2019 during office hour and the same will be closed on 05.01.2019 at 5.00 P.M and the last date of bid documents shall be received on dt.09.01.2019 up to 5.00P.M. through Courier/speed post/Registry post only. The bid documents can be obtained in the office of the U/S. on payment of cost (non refundable) mentioned in column No. 6. in shape of cash.

The authority will not be responsible if any portion of the document is not included or modified other than the approved one, as available in the Office of the undersigned.

4. The Engineering contractor applying for exemption of EMD has to produce the affidavit that he has not availed the said exemption for more than two times during the current financial year in absence of which his tender will be rejected for want of EMD.

5. Scheduled caste/ Scheduled Tribe contractors desirous of availing concession of EMD and price preference of 10% on the lowest tendered amount should submit original copy of the affidavit for the same along with tender document. Otherwise they will not be entitled to avail such facility.

6. Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, the L1 bidder who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security in shape of NSC/KVP/POSB/POSB/TDR of Scheduled Bank pledged in favour of the Chief District Medical and Public Health Officer, Mayurbhanj, Baripada / bank Guarantee in favour of Chief District Medical and Public Health Officer, Mayurbhanj, Baripada from any Nationalised/ Scheduled Bank in India counter guaranteed by the local branch at Bhubaneswar within 7(Seven) days from the date of issue of Letter of Acceptance (LoA) by the Chief District Medical and Public Health Officer, Mayurbhanj, Baripada (by post) to the successful bidder otherwise the bid of

the successful bidder shall be cancelled and the Earnest Money Deposit/ Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder.

7. If the rate quoted by the SC and ST category contractors comes to 14.99% (decimals upto two numbers will be taken for all practical purposes) less than the estimated cost after availing 10% price preference as per Para-2 of Works Department Resolution No.27748 dt. 11.10.1977, then the tender shall be finalized by the tender accepting authority through a transparent lottery system along with other category of contractors whose rate are 14.99% less than the estimated cost.
8. G.S.T. as applicable shall be paid extra over and above the work value. The contractor shall however be required to submit the TAX INVOICE along with the R.A./ Final bill for release of the G.S.T. amount by the Department.
9. The Bids will be opened at **11.00 A.M. on 11.01.2019** in the office of the undersigned in presence of the bidders who wish to attend. If the office happens to be closed on the last date of sale, receipt and opening of bids, the respective dates will be shifted to next working day.
