TERMS AND CONDITIONS

2. The Tender Paper in the prescribed format shall be collected from the office of the D.S.W.O., Mayurbhanj on payment of Rs.500/-per vehicle ( Rupees Five hundred )only which is not refundable.
2. The Tender papers shall be furnished in the office of the D.S.W.O., Mayurbhanj by hand / by Regd. Post on any working day till **10.01.2019** during office hour and will be opened on the next day i.e. **on 11.01.2019 at 11.00 A.M.** in the Office Chamber of the undersigned in presence of the Tenderers or their Authorized Agents.
3. The sealed cover should be addressed to the D.S.W.O., Mayurbhanj and should be superscribed as "**Sealed Tender for disposal of Condemned Vehicle**".
4. The competitors shall be required to pay earnest money deposit amounting to Rs.7000/-, Rs.4000/-, Rs.3500/-, Rs.3000/- & Rs.3000/- for vehicle of ICDS Project, Khunta, Morada, Thakurmunda, Baripada & Kuliana ( Chandua) respectively in shape of Bank Draft which shall be subjected to refund immediately except in case of the highest offered accepted by the competent authority.

5. Offers received shall be opened and considered in the presence of tenderer or their authorized agent. The highest offer at or above the upset price shall be approved by the competent authority then and there. The highest tenderer shall be deposit 25% of the amount immediately after the announcement and the rest within 7 days of the approval of the order.
6. On failure to make payment as aforesaid, the deposit (including earnest money) shall be forfeited and the vehicle put to fresh tender as the case may be.
7. The vehicle shall not be delivered to the tenderer / party until after full payment and compliance with the requisite formalities Tools, implements and spare parts shall not be delivered with the vehicle.
8. The tenderer / party shall remove the vehicle from site within 7 days from the date of depositing the full amount of tendered / negotiated money. Custody or safe guard of the vehicle shall be the responsibility of the tenderer / party and no claim or complaint on the account shall be admissible.
9. On failure to remove the vehicle within the time as aforesaid, ground rent at the rate of one percent of the tendered /negotiated money shall be charged for each day or part of the day till the removal of the vehicle from the site.
10. Where the ground rent be charged exceeds the sale price deposited the tenderer / party shall cease to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become absolute property of Government free from all encumbrances and disposed of by fresh sealed tender as the case may be.
11. The undersigned reserves the right to accept or reject the sealed tender without assigning any reason thereof. Decision of the undersigned is final in case of any dispute.
