







Scope of Bidder: The Bidder shall provide the engraved LOGO in the prescribed specification which sample copy uploaded in the website. The materials will be delivered at the respective Block Headquarters. The Quoted rate will include the cost of Marble, cost of engraving, cost of approved color, Cost of transportation including loading & unloading, Taxes and Duties as applicable including 1% labour cess to be deducted from work bill at source. He is responsible for supplying the materials in Good Condition without Damage. The transit insurance if any is the responsibility of the Bidder.


