1.0 MATERIALS TO BE DISPOSED OFF.

Condemned vehicles are to be disposed as per location wise as under the Group 1.1. Annexed.

- The participants may inspect the vehicles during the official working hours with 1.3. permission from the CDM & PHO/Supdt.SDHs/Medical Officer of CHC etc.
- Vehicles will be sold in "as is where is basis" with outstanding tax liabilities. 1.4.
- 2.0 **TENDER FORMS:-**
- 2.1 The terms, conditions and guidance of tenderers should not be submitted with The TENDER FORMS. Only tender form should be submitted.
- Tender shall be submitted in the "TENDER FORM" Annexed. 2.2
- The tenderers will clearly write the group No.in the column prescribed, where they 2.3 should quote the rate. Any mistake noticed will be decided by the Tender screening committee and its decision will be final.
- The tenderers shall quote the rate visibly in words (Block letters & Numerical) to avoid 2.4 confusion.
- 2.5 The tender paper shall be submitted in sealed cover super scribed "TENDER FOR DISPOSAL OFF CONDEMNED VEHICLES FOR 2019" with mention in detail address on the cover with their Telephone No./Mobile No. etc.
- All tenderers shall submit the tender by Regd.Post/ Speed post only. 2.6
- Tender will be opened on the stipulated date and time by the constituted tender 2.7 screening committee comprising of the following members of Dist.level Officers/Medical Institution Officers. DISTRICT LEVEL
  - 1) CD& PHOMO.- Chairperson
  - 2) DPHO, Member ADPHO (FW)- Member
  - 3) Any other selected-Gazzeted Officer by the CDM & PHO.

  - 5) State level Officer.

## 3.0 EARNEST MONEY:-

- 3.1 Rs.1000.00 (Rupees One thousand) only for each vehicle will be treated as E.M.D. Even for the Registered Co-operative Society participates the tender they are to furnish E.M.D.Rs.1,000/-(Rupees One thousand) only of each vehicle in the shape of B.D.as indicated in para- 3.2.
- E.M.D. shall be furnished in form of Bank Draft only drawn in favor of the C.D.M& P.H.O./Head of the Institution for respective district vehicles and attached to each tender paper. The B.D. to be drawn in concerned nearer S.B.I.Brach.
- To facilitate immediate refund of E.M.D. the tenders should submit separate Bank Draft for each vehicles against which they have tendered with a stapled slip to each Bank Draft indicating the vehicle No. If it is not done, soothe conducting Authority (CDMO/Head of the Instn.) may not be responsible for early refund of E.M.D.in case of successful tenderers. The E.M.D.of 2nd Highest Tenderers shall not be refunded until the successful tenderer deposit the full amount and tender is finally decided in his favor.
- 3.4 E.M.D.of unsuccessful tenders will be refunded after finalization of tender and within 30 days. No interest will be claimed by the tenderer.
- Where a renderer has submitted one Bank Draft covering more than one vehicle and if there is highest offer in respect of any vehicle the Bank Draft will be retained till final decision of the conducting authority.
- 3.6 Retention of E.M.D.of the highest and 2nd highest tenderers does not guarantee decision in favor of the tenderers decision of the conducting officer shall be final.
- 3.7 The tenderer quoted the highest price or above the price approved by the authority will be asked to deposit 25% of the tender value on the day of opening of the tender by open announcement.
- 3.8 On failure to make final payment the aforesaid deposits (including earnest money) of the tenderer shall be forfeited and the vehicle put to fresh tender as the case may be.
- 3.9 The tenderer should clearly mention their name &designation, whether they may be Govt./private organization.
- 4.0 PAYMENT ETC.
- 4.1 In the event of a tenderer not coming forward to deposit the rest 75% amount due within 7 days i.e. from the date of deposit of 25% the conducting authority will be free to dispose the material to any other party and the EMD with 25% of tender value of the tenderer shall be liable for forfeiture.
- 4.2 On receipt of intimation the tenderer will contact the concerned officer in the office of CDM&PHO/Head of Institution obtaining a money receipt after depositing the total amount due.
- 4.3 On payment of total amount clearance will be issue by the CDMO/Head of Institution.
- 4.4 No tender money will be accepted without the presence of the successful bidder or their authorized agents.
- 4.5 The vehicles will be handed over to the successful tenderer on receipt of full payment of the accepted tender money.
- 4.6 Tools, implements and spare parts shall not be delivered. R.C.Books etc. which are not available shall not be delivered along with the vehicle.
- 4.7 The tenderer shall have to take the vehicle from the site mentioned above within 7 days after finalization of tender custody & safety of the vehicles shall be the responsibility of the tenderer after it is finalized.

## 5.0 GROUND RENT

- 5.1 In case of vehicle is not taken within the stipulated period ground rent @ 1% of the tender money shall be charged for each day or part of the day till the vehicle is removed from the site.
- Where the ground rent so charged exceeds the sale price deposited by the tenderer then he is ceased to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become absolute property of Govt.& free from encumbrances & may be disposed by fresh tender or as per decision of conducting authority.

## 6.0 <u>DISQUALIFICATION</u>

- 6.1 A tender may be summarily rejected by the screening committee for the following reasons.
- 6.1.a Tender not submitted in the prescribed tender form.
- 6.1.b Tender received beyond the date and time stipulated.
- 6.1.c Tenders not submitted in closed sealed cover.
- 6.1.d E.M.D. failing short of stipulated amount or without E.M.D.
- 6.1.e Sealed tender paper of any of the absentee tenderer may not be opened & returned to the seal intact within 30 days.

## 7.0 CORRESPONDENCE

- 7.1 All correspondence including the legal complication on the tender and disposal of the vehicle, to be complied by the concerned C.D.M.O./Head of the Institution.
- 8.0 <u>AUTHORITY</u>
- 8.1 The authority reserves the right to accept or cancel any tender or all tenders without assigning any reason thereof & may settle the auction with the highest bidder on negotiation.
- 8.2 In case of dispute on any matter the interlunation and decision of the authority shall be final and binding and the legal procedures if any should be in the jurisdiction of the court of the state of Odisha.
