 - (i) Attested photo copy of up to date Registration Certificate of vehicle
 - (ii) Attested photo copy of the PAN card / TIN No./ GST certificate (should be in his own name)
2. The rates inclusive of all taxes & GST without driver & all maintenance charges per month.
3. The POL will be borne by the District Welfare Officer, Mayurbhanj / vehicle owner while submitting the bill / vouchers along with log book.
4. The vehicle is to be stationed at District Welfare Office, Mayurbhanj, Baripada and journey from owners / garage to office or vice- versa is not payable.
5. No overnight or night halt charges are also payable during engagement of the vehicle in the office.
6. The committee shall not be bound to accept the lowest rate, but the acceptance of the quotation shall be good condition of the vehicle and should not be more than 2 years old. The final accepted bidder shall strictly confirm to the approved rates.
