# TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful hidder for providing a vehicle on hire or monthly rent basis.

- 1. The hired vehicles, during period of contract, shall have all necessary volid MV documents such as a valid Registration Certificate, insurance Certificate. Fitness Certificate, valid Contract Carriage Permit, proof of age to date tax payment etc. and D.L. of the driver available all the times. The Department Office bring the vehicle shall not be responsible for any dismage loss caused to hired vehicles or loss of life almany made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such Integration.
- The bare charges to be paid for monthly easis is final but does not include cost of diesel, which is to be paid separately buting on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of space parts, Lubricating oil of Engine, Gear Box & differential Cookin, Tyres & Tubes, Battery etc. will be borne by the bidder.
- It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be beene by the owner.
- In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidser.
- In case of the vehicle do not report regularly, the mahority will be at liberty to reject the agreement and may engage vehicle from other source.
