Terms and conditions

1. Cost of Tender paper : Bids must be accompanied by paper cost of the amount specified for the work in the table col-7 in shape of demand draft (non-refundable) drawn in any Nationalized Bank in favour of BDO Rairangpur and payable at AXIS BANK Rairangpur.
2. EMD : The bid must be accompanied with EMD Amount as specified against each work in shape of NSC/POTD/KVP/POSB Deposit receipt of the scheduled commercial bank dully pledged in favour of BDO Rairangpur..
3. Download & Receipt of tender paper: Download of the Bid documents will start from the date of publication i.e. from dt.05.08.2023 to 16.08.2023 up to 5.00 PM. Bid should be submitted to the office of the Block Development Officer, Rairangpur ,Mayurbhanj , through speed post/Regd.post only (No tender paper will be received by hand service) and super scribed as "NAME OF THE WORK " BID IDENTIFICATION NO. B.D.O. RAIRANGPUR..((Written in Capital letter) on the Body cover. The last date of receipt of the bid documents will be 16.08.2023 up to 05.00PM.
4. Date of Opening of the tender paper: The Bids will open on 18.08.2023 at 11.30 AM at the conference Hall , Panchayat samiti ,Rairangpur ,MAYURBHANJ in the presence of the

bidders who wish to attend . If the office happens to be closed (holiday) on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue without further notice. However , date of tender paper opening may be postponed as per the convenience of the authority by intimating all the concerned tenderer through notice affixing to .

5. Additional performance Security Deposit :- Additional performance security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender as per works depts. Letter No. 4710 dt. 12.4. 2022 in such an event . only the successful bidder who has quoted less bid price/rates than the estimate cost put to tender shall have to furnish the exact amount of differential cost of reflected below as additional performance security (APS) in shape of N.S.C./K.V.P /Postal time deposit pass book/ Term Deposit receipt duly pledged in favor of BDO Rairangpur within seven days . otherwise the bid shall be cancelled and the security deposit shall be forfeited . Further , proceeding for blacklisting shall be initiated against such bidders.

Below 5%	No Additional performance security
From 5% & above and below 10%	50% of Difference between estimated cost put to tender and Bid amount.
From above 10%	150% of Difference between estimated cost put to tender and Bid amount.

6. The following Documents should be furnished with the tender paper failing which the tender is liable to Rejection.
- EMD Pledged in favour of BDO Rairangpur
 - Attested copy of valid Contractor Registration Certificate .
 - Attested copy of valid Pan Card & GST filling reports for the month up July-2023 otherwise Tender papers will be rejected.
 - SC/ST Contractors submit original Affidavit in support of caste certificate and attested copy of caste certificate.
 - Bank Draft towards cost of Tender paper in favor of BDO Rairangpur.
7. Engineering contractors desiring to avail the exemption facility of EMD should submit an original affidavit as regards of being the Engineering contractor and the fact of availing award of work without submission of EMD/ISD during the current financial year. He should also produce original contract license at the time of opening of tender document to make necessary entry to that effect as such facilities are limited to three participation in tender during a financial year . Otherwise, their tender will be liable for rejection.
8. The SC/ST Contractors desirous of availing preference should submit an original affidavit in support of caste certificate & availing of preference and attested copy of caste certificate . Otherwise their tender will be treated as general bidders.
9. G.S.T. as applicable shall be paid extra over and above the work value. The contractor shall however be required to submit the TAX INVOICE along with the R.A./ final bill released of the G.S.T. amount by the department .
10. Shortfall of any required documents . Tender paper is liable for rejection.
11. A bidder can submit only one tender paper for a particular work. Submission of more than one tender paper by a bidder for particular tender will liable for rejection of all such tender papers.
12. Other details can be seen in the bidding document.
13. The authority reserves the right to reject any or all the tender without assigning any reason thereof.

Bid documents will be available at District NIC website ie www.mayurbhanj.nic.in and will be accompanied by the paper cost of the Tender paper in shape of Demand Draft payable as AXIS BANK ,RAIRANGPUR ,Mayurbhanj and DTCN with all required documents of bidders as mentioned in Tender call Notice to be sent to the office of the Block Development Officer, Rairangpur.
