3. The quotation will be opened in presence of the purchase committee at the office chamber of the Asst. Director of Sericulture, Baripada at 12 Noon on dt 17-08-2023.
4. The sealed quotation should be clearly marked as quotation for supply of vermi-compost, Organic Manure and it should be clear the address of the supplier.
5. The rate quoted should be included of all taxes & transportation charges (i.e rate of delivery) at the field of concerned TasarRearer co-operative society.
6. The quoted party should submit the testing report of the product of the company from state Govt/Central Govt testing organization on at the time of submission of quotation.
7. The Material should be supplied within 10 days of the order for the supply materials samples will be taken randomly from any supply place in the presence of the party and will be send for testing report. After received of the testing report and verification of the stock by the post-delivery inspection team the payment will be made as per availability of the fund on online of MGNREGA and RKVY.
8. Valid latest ITCC,GST Registration certificate and PAN card should be furnished along with quotation.
