### TERMS AND CONDITIONS OF TENDER FOR TENT & ALLIED WORKS FOR PALISHREE MELA -2020 Period – 09<sup>th</sup> -13<sup>th</sup> April 2020, Mayurbhani

- 1. Sealed tenders are invited from the reputed firms, decorators and tent houses having the work experience of Exhibitions or similar nature of works..
- 2. The tenderer should have registered his firm under Commercial Tax (GST), Service Tax and having PAN No.
- 3. The work will be assigned to a firm for Pallishree Mela only. So, the rate quoted should be inclusive of all taxes offered by the tent houses / firms and should be valid for the given period.
- 4. The duration of the exhibition will be for 5 days as per the details given below. In case of there is any extension of Mela period, no extra payment will be entertained for the additional days. All the desired works should be completed at least one day before the scheduled inauguration date and time of the Exhibition and should hand over all the works as per the specification, to the in-charge of exhibition.
- 5. The bidder should have in the business of providing Tent or Event Management Services to the Central / State Government / Corporate Bodies /National Organizations for at least 1 or 2 years from the date of opening of the proposal.
- 6. Experience Certificate/ Work Order showing successfully completed similar type of works during last three year ending last day of the month previous to the one in which application are in invited should be either of the following.
  - a. Three Similar [Tentage or Event Management works for National/ State/ District Level Exhibitions] completed works/assignments costing not less than the amount equal to Rs 6.00 Lakhs (Rupees Six Lakhs) each OR
  - b. Two similar type of works costing not less than the amount equal to Rs.8.00 Lakhs (Rupees Eight Lakhs) each OR

7. On completion of the exhibition, the contractor shall have to take away all the materials within 3 days & vacate the site with the same condition while occupying the ground.

- 8. The contractor should be prepared to provide additional materials in case of requirement at the market price for the items not mentioned in the tender.
- 9. The final payment will be made on the basis of the actual work done and Work Assessment Report in the specified format by the Mela and Mahostav in-charge. Part payment / release of advance will be made only after inauguration of the said exhibition on the satisfaction of the authority. The contractor shall not use any additional materials other than the work specified in the work order without the prior permission of the Mela and Mahostav -in-charge. In case of any additional requirement, the contractor has to take the prior written permission from the Mela-in-charge which should be submitted with the bill.
- 10. The tenderer will be responsible for upkeep and maintenance of the entire work done by him till the closing of the exhibition. The undersign will not be responsible for any breakage, damage, fire, theft etc. of his materials and he has to take suitable step for insurance of his goods used in the exhibition for the above purpose.
- 11. No part of the contract will be sub-let without the prior written permission of the authority.



12. For convenience and effective delivery the tender is to be treated as a package of services. Hence, the firm quoting the lowest quotes and submitted required documents mentioned in SI. No. 1 & 2 will be selected for the purpose.

- 13. It shall be the responsibility of the successful tenderers / contractors to obtain requisite permission for electricity connection / fire services for the exhibition period from statutory bodies. The tenderers have to supply the fire protection equipment like extinguisher as per the requirement from the Fire Officer of the concerned area and adhere to the fire safety norms.
- 14. In regard to electrical fittings etc. the contractor shall have to engage qualified licensed electrician / contractor entitled to erect, handle and maintain high tension supply line and its up keep and maintenance.
- 15. Firm /Agency will be responsible for cleaning and sweeping of the entire Mela ground every day. The agency have to engage sufficient numbers of manpower for that and Mela ground should be ready with proper cleaning by 9 AM everyday during the exhibition period.
- 16. The tenderers are required to deposit an earnest money of Rs. 10,000 /- (Rupees ten thousand) only in shape of demand draft / pay order in favour of <u>Chief Executive, DSMS, Mayurbhani</u> payable at Baripada. The E.M.D amount of the successful tenderer will be kept with till the completion of the exhibition. ### CONCEPT OF THE PALLISHREE MELA

The Pallishree Mela will be designed to create the atmosphere of a village where there will be an indigenous and contextual setting for folk artisans and entrepreneurs to display, demonstrate and market their skills and products in an environment akin to their own habitat. The entire layout, design and landscaping will be vernacular in approach. It will be a congregation of stalls grouped as per their classification harmoniously. The whole set up would create awareness on rural ethnic products among the masses.

The overall objective of the Mela is to popularize the ethnic and other rural products of different States and Districts and create opportunities for the artisans / producers to build up long term marketing tie-up with prospective buyers around the country.

In general, the following works will be required to be taken up:

- 1. Erection of Stalls
- 2. Coordination Cell-cum-VIP Lounge
- 3. Main Entrance & Exit Gate
- 4. Ground Electrifications (General) Additional Electrical Requirements

#### 1. <u>Erection of Stall</u>:

General Specification: The Ground lay out should be prepared in a compact manner from security point of view. ## 4. <u>Ground Electrification:</u>


