PPE (Personnel Protection Equipment)

A. PPE Kit

A.1 Gloves (Double pair)

- Nitrile
- Non-sterile
- Powder free
- Outer gloves preferably reach mid -forearm (minimum 280 mm total length)

A.2 Coverall (medium and large)

- Impermeable to blood and body
- Single use
- Avoid culturally unacceptable color e.g. black
- Light colors are preferable to better detect possible contamination
- Thumb/finger loops to anchor sleeves in place

A.3 Goggles

- With transparent glasses, zero power, well fitting , covered from all sides with elastic band / or adjustableholder
