- The sealed tender paper will be received on working days till 3.00 PM of date 31/08/2020. The same should be submitted either through registered /speed post addressing to The BDO, Kusumi or same may be dropped in the tender box kept in the Block office, Kusumi during working hour. The sealed envelope shall be superscribed as "Tender Paper". The undersigned will not be held responsible for any delay in the postal service.
- The tender paper will be opened at 11 AM of date 2/09/2020 in presence of the bidders or their authorised representatives and Block tender comittee.
- The EMD is to be deposited in shape of NSC/KVP/POTD/deposit of any Nationalise Bank duly pledged in favour of the Block devlopment Officer ,kusumi.
- The following documents should be furnished along with the tender paper failing which the tender is liable for rejection.
  - a. EMD duly pledged in favour of the BDO,kusumi.
  - b. Attested copy of the Contractor registration certificate.
  - c. Attested copy of PAN CARD /labour Lisence/GST clearance certificate.
