A sum of Rs.5,000/- shall be deposited by the intending bidders in shape of account payee bank drafts born in favour of the District Employment Officer, Mayurbhanj, Baripada & submitted along with the tender as security deposit. After completion of the tender process, the amount will be refunded to unsuccessful bidders.

- The vehicle must achieve a fuel efficiency of 17 K.M.s per Liter.

  specifically provided in the general bid information to be furnished with the quotation/tender

## TERMS & CONDITIONS FOR HIRING OF VEHICLES

The Following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

- The hired vehicles, during period of contract, shall have all necessary valid MV documents such as:-
- (a) Valid Registration Certificate, (b) Insurance Certificate, (c) Fitness Certificate, (d) Valid Contract Carriage Permit, (e) Proof of up to date Tax Payment etc. and (f) D.L. of the driver available all the times.

The Department/Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss or life/ injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.

- 2. The hire charges as per the O.M. No.30464/F., Dt. 06.09.2019 of the Principal Secretary to Govt., Finance Department, Odisha, Bhubaneswar will be paid for monthly basis is final but does not include cost of Petrol, which is to be paid separately basing on actual consumption. All the expenditure of the wehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tires & Tubes, Battery etc. will be borne by the bidder.
  - It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
  - In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
  - In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
  - The vehicles shall report for duty for minimum of 25 days in a month.
