- 1 The tender paper can be obtained from the Block Development Officer ,Bisoi on payment of Cost of the tender paper (non refundable) in shape of Cash.
- 2 The tender paper will be sold from date 02/12/2020 to 16/12/2020 on working days only from 11.00 AM to 5.00 PM in the Office of The Panchyat Samiti,Bisoi.
- 3 The sealed tender paper will be received on working days till 5.00 PM on 18/12/2020 .The same should be submitted either through registered /speed post addressing to The BDO, Bisoi or same may be dropped in the tender box kept in the Block office,Bisoi during working hour. The sealed envelope shall be super scribed as "Tender Paper".The undersigned will not be held responsible for any delay in the postal service.
- 4 The tender paper will be opened at 11.00 AM of date 22/12/2020 in presence of the bidders or their authorized representatives and Block tender committee.
- 5 The EMD is to be deposited in shape of NSC/KVP/POTD/deposit of any Nationalized Bank duly pledged in favour of the Block Development Officer ,Bisoi.
- 6 The following documents should be furnished along with the tender paper failing which the tender is liable for rejection.
 - a. EMD duly pledged in favour of the BDO,Bisoi.
 - b. Self Attested copy of the Contractor registration certificate.
 - c. Self Attested copy of PAN CARD and GST clearance Certificate with active GSTIN.
 - d. Money receipt of DTCN (Tender Paper) shall be enclosed in original.
 - e. Attested copy of Caste certificate for SC/ST Contractor desirous of availing preference.
 - f. The Engineering Contractor desirous of availing exemption of EMD should submit an affidavit to the effect that he has not availed exemption of EMD facility more than three times in the current financial Year.
- 7 The Labour License must be submitted at the time of agreement.
- 8 The Schedule Caste/Schedule Tribe/Physically handicapped Contractors desirous to avail the exemption of EMD and price preference (as applicable) ,should mention in the Affidavit.
- 9 If the less rate quoted by the tenderer is more than 10% and within 15% the additional performance security is to be deposited in shape of NSC/KVP/Bank Draft /Banker's Cheque which are duly pledged in favour of the BDO,Bisoi at the time of agreement as per revised codal provision of Govt. in Works Department.



- 10 The EMD amount will be forfeited if the Tenderer backs out from the offer of acceptance of Tender by the Competent authority
- 11 The Tenderer has to show all required original documents at the time of opening of the tender for verification.
- 12 The Contractor must have executed similar nature of works and financial turn over in last three years. The tenderers are required to submit the list of T&P possessed, list of works executed and successfully completed the Civil works during last three years. The above information should be certified by the concerned authority not below the rank of BDO/Executive Engineer.
- 13 An affidavit in support of the authority of document no relation certificate (not below the rank of Assistant Engineer).
- 14 If the rate quoted by the Tenderers is found to be same, Tender Committee will decide the Tender.
- 15 Excess bid amount quoted by the bidder ,if any, in respect of any work shall not be accepted.
- 16 The authority deserves all right to reject or cancel any or all Tender without assigning any reason thereof.


