



Terms & Conditions:

1. The organization /NGOs/Firms/ Society should be registered under Society Registration Act/Company Registration Act or any other act of Government as applicable. Priority should be given to those who have been authorized on getting due approval of Detailed Project Report on Lac cultivation on Kusum tree and Lacquer craft training from Government agency like : Indian Institute of Natural resins and Gums, Namkum Ranchi Govt. of India and /or other similar reputed Government Institutions or Institutions approved by ICAR.
2. The organization /NGOs/Firms/ Society submit EoI for Lac cultivation for 100 ST beneficiaries in 200 nos. of Kusum trees (2 nos. of kusum tree per beneficiary) should produce the Detailed Project Report (DPR) along with the rate/cost norm (in Rs.) of tools and equipments (**kusumi Brood Lac, synthetic net, Plastic Sutali , Pruning Secateur, Spray machine and Medicine Carbendezim and Fipronil**) used for Lac cultivation project with due approval from Government agency like Indian institute of Natural Resins and Gums, Namkum Ranchi Govt. of India and /or other reputed Government Institutions or institutions approved by ICAR.
3. The organization /NGOs/Firms/ Society submits EoI For Lacquer craft training of 60 ST beneficiaries for 6month duration should produce the Detailed Project Report (DPR) along with the rate/cost norm (in Rs.) of mentioning detail particulars like :Institutional Charges, stipend for trainees , remuneration for instructor , Raw materials for training , tools & equipments and

other charges used for Lacquer craft training project with due approval Government agency like: Indian institute of Natural Resins and Gums, Namkum Ranchi Govt. of India and /or other reputed Government Institutions or Institutions approved by ICAR..


4. The organization /NGOs/Firms/ Society should have at least five years proven experience in under taking lac cultivation and Lacquer craft training programme by any state or central Govt. may be given preference.
5. The organization /NGOs/Firms/ Society should produce /submit the detailed audited report of last 5 years for executing Lac cultivation and Lacquer craft training at their level.
6. The PIA s will provide handholding support to tribal beneficiaries for implementation of Lac cultivation and Lacquer craft training programme.
7. The organization /NGOs/Firms/ Society should have to mention clearly their rates regarding hand holding support to beneficiaries (In Rs.) in the EoI.
8. The authority reserves all the rights to cancel or modify the EoI without assigning any reason/s thereof.
9. The PIA or Bidder having quoted the lowest bid rate of overall cost, including cost of all items, in DPR is selected in final process and given order of execution.


