Terms and condition

- 1 The Tender Paper can be obtained from the Block Development Officer, Rairangpur on payment of Cost. of the tender paper (non refundable) in shape of cash.
- 2 The Tender Paper will be sold from date.01.01.2021 to 10.01.2021 on working days only from 10.30 AM to 4 PM in the office of the Panchayat Samiti, Rairangpur.
- 3 The sealed Tender Paper will be received on working days till 03.00 PM from date. 01.01.2021 to 10.01.2021.The same should be submitted either through registered/ speed post addressing to the BDO, Rairangpur or same may be dropped in the tender box kept in the Block office, Rairangpur during working hour. The sealed envelope shall be superscribed as "Tender Paper". (Name of the Project & Sl. No.) The undersigned will not be held responsible for any delay in the postal service.
- 4 The Tender Paper will be opend on 11 AM on date.12.01.2021 in presence of the bidders or their authorised representatives and Block tender committee.
- 5 The EMD as mentioned in col.6 is to be deposited in shape of NSC/KVP/POTD/ Fixed Deposit of any Nationalised Bank duly pledged in favour of the Block Development Officer, Rairangpur. Payable at Rairangpur. Tenders not accompanys with EMD shall be liable for rejection.

- 6 The following documents should be furnished along with the tender paper failing which the tender is liable for rejection.
 - a. EMD duly pledged in favour of the BDO, Rairangpur.
 - b. Self Attested copy of the contractor valid registration certificate.
 - c. Attested copy of PAN CARD/ Labour Licence/GST clearance Certificate.
 - d. Money receipt of DTCN (Tender Paper) shall be enclosed in original.
 - e. Attested copy of caste certificate for SC/ST contractor desirous of availing preference.
 - f. Signed copy of DTCN and price bid duly filled in and signed by the tenderer.
 - g. An affidavit regarding authenticity of the credentials.
 - h. Name of the Project and Sl. No. will be mentioned in cover of the Envelope.
 - i. Mailing address of registered office/site office of the bidders for future correspondence.
- 7 The EMD amount will be forfeited, if the Tenderer backs out from the offer of acceptance of Tender by the competent authority.
- 8 The Tender has to show all required original documents at the time of opening of the tender for verification.
- 9 The contractor must have executed similar nature of works and financial turn over in last three years. The tenderers are required to submit the list of T & P Possessed, list of works executed and successfully completed the Civil works during last three years. The above information should be certified by the concerend authority not below the rank of BDO/ Executive Engineer.
- 10 An affidavit in support of the authority of document including No Relation Certificate and detail work programme should be attached with the Tender Paper.
- 11 If the rate quoted by the Tenderers is found to be same, Tender Committee will decide the Tender.
- 12 Excess bid amount quoted by the bidder, if any, in respect of any work shall not be accepted.
- 13 The authority Reserves the rights to reject or cancel any or all the Tender without assigning any reason thereof.
- 14 All the tenders where rate quoted is more than 15% less than the scheduled rate will be rejected.
- 15 The tender is to be submitted in sealed envelope with all documents described and required as per the relevant clauses of the DTCN and Special Conditions if any. The envelope to be superscripted as the bid of the work as mentioned in column No.3 of the Tender Call notice.
- 16 The Engineer Contractor seeking exemption of EMD is to be enclosed an affidavit regarding the number of tender they have participated with exemption of E.M.D prior to date during the current financial year 2020-21. Also she/he will have to produce his/her original licence at the time of opening, so that the authority will enter the same in the license which is mandatory. *For all work process OMBADC grade here will be followed.*
- 17 SC/ST Tenders can avail facilities as per Govt. circular.
- 18 The bidder shall have to furnish an affidavit along with the bid regarding the authenticity of the bid document.
- 19 Additional performance Security deposit shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount as Additional performance Security(APS)in shape of Demand Draft/ Term Deposit Receipt pledged in favour of Block Development Officer, Rairangpur within Seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder.

- 20 All bids received will remain valid for a period of 90 days from the last date of receipt of bids and the validity of the bids can also be extended, if agreed to by the bidders with the Department.
- 21 If the L-1 bidder does not turn up for agreement after finalization of tender, than she/he shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case L-2 bidder if fulfill, other required criteria would be called for drawing agreement for execution of work subject to the condition, that L-2 bidder negotiate at per with the rate quoted by the L-1 bidder otherwise tender will be Cancelled.
- 22 The rates to be quoted by the contractor shall be excluding GST. The implementation of the GST rules by the Govt. of Odisha is to be accepted by the bidder at any point of time.
