The quotationers or their representatives are requested to be present at 3.00 PM on 18.02.2021 at the time of opening of the Tender box in this office.

The articles are required to be delivered in the office of the ICDS Projects Udala within 30 (Thirteen) days from the date of receipt of supply orders.

- 2) No quotation will be entertained after the stipulated date and time.
- 3) The quotationer has to quote single rate the printing in the schedule prescribed for the purpose inclusive of all taxes, transporting cost and other incidental charges.
- 4) The quotationers has to submit GST clearance certificate valid up to 31st March 2021, Firm Registration certificate, and Xerox copy of PAN Card along with the quotation .
- 5) The quotationers has to submit the original money receipt of terms & conditions purchased.
- 6) The quotationer shall deposit security money of Rs. 2000/- (Rupees two thousand) only in the office of the undersigned and attached the money receipt with the quotation. The security money of the successful quotationer will be refunded after supply of article as per the requirment.
