2. The Product shall be BIS/EN ISO Certified & the supplier has to furnish necessary certificate.
3. Weight of the Machine should be ranging from 8-10 kg and the dimensions should be such that can be used by the field staff comfortably in the hilly forest area.
4. The successful bidder has to deliver the 70 (Seventy) numbers of fire Blowers of approved Make & Model at Baripada Forest Division, Baripada, Mayurbhanj within 5 days of finalization of Tender failing to do so the EMD will be forfeited
5. The successful bidder has to impart field training to Forest Staff free of cost.
6. The bidder has to deposit EMD of Rs. 5000/- which shall be refunded after closure of Tender.
