


- 1 The tender paper can be obtained from the Block Office ,Kusumi on payment of Cost of the tender paper (non refundable) in shape of Cash.
- 2 The tender paper will be sold from date 25/03/2021 to 9/04/2021.on working days only from 11.00 AM to 4.00 PM in the Office of The Panchyat Samiti,Kusumi.
- 3 The sealed tender paper will be received on working days till 1.30 PM of date 19/04/2021.The same should be submitted either through registered /speed post addressing to The BDO, Kusumi or same may be dropped in the tender box kept in the Block office,Kusumi during working hour.The sealed envelope shall be superscribed as "Tender Paper".The undersigned will not be held responsible for any delay in the postal service.
- 4 The tender paper will be opened at 10 AM of date 20/04/2021 in presence of the bidders or their authorised representatives and Block tender committee.
- 5 The EMD is to be deposited in shape of NSC/KVP/POTD deposit of any Nationalise Bank duly pledged in favour of the Block development Officer ,kusumi.
- 6 The following documents should be furnished along with the tender paper failing which the tender is liable for rejection.
 - a. EMD duly pledged in favour of the BDO,kusumi.
 - b. Attested copy of the Contractor registration certificate.
 - c. Self attested copy of PAN CARD /labour Lisence/GST clearance certificate with active GSTIN.
 - d. Money receipt of DTCN (Tender Paper) shall be enclosed in original.
 - e. Attested copy of Cast certificate for SC/ST Contractor desirous of availing preference.
 - f. The Engineering Contractor desirous of availing exemption of EMD should submit an affidavit to the effect that he/she has not availed exemption of EMD facility more than three times in the current F.Y.
- 7 The Schedule cast/Schedule Tribe/Physically handicapped Contractors desirous to avail the exemption of EMD and price preference (as applicable) ,should mention this in the Affidavit.
- 8 If the less rate quoted by the tenderer is more than 10% and within 15% the additional performance security is to be deposited in shape of NSC/KVP/Bank Draft /banker Cheque which are duly pledged in favour of The BDO,Kusumi at the time of agreement as per revised codal provision of **Govt. in Works Department.**
- 9 The EMD amount will be forfeited if the Tenderer backs out from the offer of acceptance of Tender by the Competent authority
- 10 The Tenderer has to show all required original documents at the time of opening of the tender for verification.
- 11 An affidavit in support of the authenticity of documents including no relation certificate (not below the rank of Assistant Engineer)..

- 12 If the rate quoted by The Tenderers is found to be same, Tender Committee will decide the Tender.
- 13 Excess bid amount quoted by the bidder ,if any,in respect of any work shall not be accepted.
- 14 The authority deserves all right to reject or cancel any or all Tender without assigning any reason thereof.




