TENDER CALL NOTICE

No. 1430 /DWO, Dated, Baripada dt. 25-03-2021

Sealed tenders in plain paper are invited from the intending Registered authorized dealers or suppliers for supply of “(I) Mink Blankets (ii) water Purifier with R.O. and (iii) Fire Extinguisher ” etc to different hostels/Schools in Mayurbhanj district under ST & SC Development Department for the year 2020-21.

Categorically, item wise specification is mentioned as follows. **Branded & ISI Marked items to be preferred.** The bidder has to **super scribe** on the envelop, that for which category of item, he/she intends to participate in the tender.


The bidder shall submit the following documents along with the tender papers:-

- (i) Valid company authorisation/ Govt. Registration Certificate of the Firm.
- (ii) Up to date (Recent) GST Return Certificate.
- (iii) Copy of PAN Card.
- (iv) Last one Financial year 's IT Returns (2019-20)/Assessment Year(2020-21)
- (v) Bank Account Number (Cancelled cheque)

The terms and conditions of the tender shall be as follows:-

- i) The bidder shall deposit Earnest Money Deposit (EMD) amounting to Rs. 50,000/ (Rupees Fifty Thousand) only and Non-refundable paper cost of Rs 1,000/- (Rupees one thousand) only , both separately in shape of Demand Draft in favour of the District Welfare Officer, Mayurbhanj, payable at Baripada ,separately for each category of items, along with the tender papers.
- ii) The rates inclusive of all taxes, transportation and installation (where ever necessary) to the school/ Hostel Points of Mayurbhanj District ,for each items, should be quoted , with specific Brand of the Company. The bidders must bring the sample at the time of opening of tenders.
- iii) The sealed tenders shall be received up to dt06-04-2021..... till 2.00 PM during office hours (Except holidays) through Registered Post/ Speed Post at the address of District Welfare Officer, Mayurbhanj. The rate should be clearly mentioned on the tender paper both in figure & words and duly signed by the tenderer concerned; otherwise the tender is liable to be rejected. The authority will not be responsible for any postal delay.

- iv) The tender paper will be opened on dt 07-04-2021 at 11-00 AM in the Facilitation Centre, Collectorate, Baripada by the District Level Purchase Committee. The tender without sample is liable to be rejected.
- v) The District Level Purchase Committee is empowered to reject or select the items (Sample). But the acceptance of the tender shall be based on the best quality (Branded & ISI Marked) of the materials (Samples submitted).
- vi) The Financial Bid of the rejected bidders will not be opened/ entertained. The finally accepted bidders shall strictly confirm to the approved rates and sample while supplying, otherwise the supply order will be cancelled the earnest money deposited shall be forfeited and steps may be taken for black-listing the firm.
- vii) The finally accepted tenderers shall supply the items within 15 (Fifteen) days from the Date of receipt of the supply order at their own cost to the to the School/ Hostel points of Mayurbhanj, District., in good condition. Failing which penalty will be charged, as decided by the District Level Purchase Committee, Mayurbhanj. In case of Utensils, the weight of the weighable items to be taken in the office premises of the District Welfare Officer, Mayurbhanj in presence of a empowered committee, then to be supplied to the school/Hostel points by the tenderer.
- viii) The District Level Purchase Committee reserves the right to accept or to reject any or all the tenders without assigning any reason thereof.
