1. The sale and receipt of bids documents shall available from the O/O the Block Development Officer, Bahalda from **30.06.2021 to 15.07.2021** and sale closed on **15.07.2021 at 1.00 PM** during working day (Except Sunday & Holiday) on payment of cost of bids documents in shape of Demand Draft (Non- Refundable) issued from any Nationalized Bank drawn in favour of the Block Development Officer, Bahalda payable at Bahalda or may be deposited by cash at Block Office Bahalda.
2. The tenderer are requested to submit the tender documents on or before the last date of receipt of tender paper.
3. The tenderer are requested to submit an affidavit in support of "No Relation" Certificate (not below the rank of Assistant Engineer).
4. The tender paper will be received address to O/O the Block Development Officer, Bahalda, Mayurbhanj, 757046 through Registered post/ Speed post/ Hand dropping in tender box at Block Office Bahalda on **15.07.2021 till 5.00 PM** in working day. Sealed paper must be accompanied with self attested copy of (i) Valid Contract License (ii) Valid GSTIN clearance certificate (iii) Valid PAN card (iv) Money receipt of DTCN (Tender copy) shall be enclosed in original (v) Signed copy of DTCN and price bid duly filled in and signed by the tenderer and requisite EMD @ 1% of the amount put to tender in shape of NSC/KVP/POTD/Time Deposit of any Nationalized Bank duly pledged in favour of the Block Development Officer, Bahalda. (vi) Affidavit about the authentication of tender documents. (vii) The ST/SC/Physically handicapped contractors desires to avail the exemption of EMD and price preference (as applicable) should mention in the affidavit. The with part of EMD/ un-pledged EMD on other shape and invalid PAN card/GSTIN certificate will be rejected. The tenderers must to be writing in capita letter (TENDER PAPER) on the right side top of the envelope containing the tender documents.
5. The bids received will be opened at the conference hall O/O the Block Development Officer, Bahalda in presence of the tenderers or their authorized agents on the scheduled date, time and venue as mentioned below.
  - a. Date of sale of tender paper from **30.06.2021 to 15.07.2021 up to 1.00 PM** during working day.
  - b. Last date of receipt of tender paper on same day i.e. **15.07.2021 till 5.00 PM** during working day.
  - c. Date and time of opening of the tender paper is **16.07.2021 at 11.00 AM**.
  - d. If the office happens to be closed on the date of receipt/ opening of the bids as specified the bids will be received/ opened on the next working day at the same time and venue.

7. The authority will not be responsible for any postal delay even if dispatched before due date.
8. Excess bid amount quoted by the bidders if any, in respect of any work shall not be accepted.
9. The successful tenderer quoting less than the amount put to tender has to deposit the differential amount i.e. (Tender schedule amount - (minus) his/her tendered amount) in shape of NSC/KVP/POTD/Bank Deposit receipt of any Nationalized Bank duly pledged in favour of the Block Development Officer, Bahalda at the time of agreement.
10. GST to be imposed as per Govt guideline from time to time.
11. The Engineering Contractor who will avail EMD exemption should produce the original contractor license before conduct of transparent lottery.
12. If L1 bidder does not turn up for agreement after finalization of tender, then he shall be debarred in participation in bidding for three years and action will be taken to blacklist the contractor. In that case the L 2 bidder if fulfils all other criteria would be called for drawing agreement for execution of work subject to the condition that L2 bidder negotiates as per with the rate quoted by L1 bidder, otherwise tender will be cancelled.
13. If the rate quoted by a bidder is less than 15% of the tendered amount, then such a bid shall be rejected and tender shall be finalized basing on merits of rest of bids. But if more than one bid is quoted up to 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system where all bidders/ their authorized representatives, all the Tender committee members will remain present.
14. The agency concerned should strictly adhere into the instruction of COVID-19 pandemic situation in the mind and observations of SOP and any other instruction issued by Govt. time to time. Similarly failure to payment part in to above such contact due to any such unavoidable situation may kept in mind for timing due to such situation.
