Terms and Conditions

- 1. Cost of Tender-: The Tender specifications can be obtained from the office of the Block Development Officer, Betnoti on payment of cash towards the cost of tender papers as mentioned above (Non-refundable) in shape of Cash/ Bank Draft drawn in favour of Block Development Officer, Betnoti, Mayurbhanj in any Nationalized Bank having its branch at Baripada/ Betnoti on any working days from 30.06.2021 to 15.07.2021 for the above work.
- 2. Sale of Tender papers: The Tender documents will be sold from 30.06.2021 to 15.07.2021 at Panchayat Samiti, Office, Betnoti during working hours of working days only.
- 3. Date of receipt and mode of submission of tender paper: The Tenderers have to submit the sealed tender papers in complete shape through Registered Post/ Speed Post/ may be dropped in the Tender Box kept in the Block Office, Betnoti during work hour. The sealed envelope shall be Superscribed as "Tender Paper". The undersigned will not be held responsible for any delay in the postal service.

- 4. The last date of receipt of Tender Papers is 15.07.2021.
- **5. Date of opening of Tender paper**: The Tender papers will be opened on **16.07.2021** at **11.30A.M**. in the presence of the Tenderers or their authorized representatives in the Office of the undersigned. The Tenderers have to show all required original documents at the time of opening of the Tender process.
- **6. Earnest money deposit**: The EMD is to be deposited in shape of Post Office Short term Deposit/ Term Deposit/ NSC/KVP/ Deposit receipt of any Nationalized bank duly pledged in favour of Block Development Officer, Betnoti. The Tender papers without required amount of EMD will not be considered and transfer or adjustment of EMD is also inadmissible.
- **7. Documents to be attached:** The following documents should be furnished with the tender papers failing which the tender is liable for rejection.
- (a) Original Money receipt of DTCN/ Tender paper cost.
- b) EMD duly pledged in favour of the Block Development Officer, Betnoti.
- (c) Self attested copy of Contractor valid Registration Certificate/License.
- (d) Self Attested Copy of PAN Card, Valid GST clearance Certificate.
- (e) Self Attested Copy of Valid GST registration Certificate.
- (f) Self Affidavit as regards the facts of availing award of Work.
- (G) The Schedule Caste/ Schedule Tribe/ Physically Handicapped Contractors desirous to avail the exemption of EMD and price preference (as applicable) should mention this in this affidavit.
- (H) Attested Copy of Caste Certificate issued by competent authorities in case of SC/ST Contractors desirous of availing preference.
- (I) Certificate of No relationship
- (J) Information regarding Current litigation, debarring expelling of Tendered or abandonment of work by the Tenderer.
- (K) An affidavit regarding authenticity of the credentials and detail work programme should be attached with the Tender Paper.
- (L) The Engineering Contractor desirous of availing exemption of EMD should submit an affidavit to the effect that he has not availed exemption of EMD facility more than three times in the Current Financial Year.
- 8. If any of the bidder quote less than 14.99% of the Tendered amount, then such a bid shall be rejected and the Tender shall be finalized basing on merit of the rest bids and the provision laid down as per OPWD Act, Govt. of Odisha.
- 9. Addl. performance Security Deposit: Addl. Performance Security shall be deposited by the bidder, where the bid amount is less than the estimated cost put to Tender. In such an event, only the successful Bidder, where the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the Estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Demand Draft/ Term Deposit Receipt in favour of Block Development Officer, Betnoti within Seven days, otherwise the bid shall be cancelled and the Security deposit shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder.

If the less rate quoted by the Tenderer is more than 10% and within 15%, additional Performance Security is to be deposited in shape of NSC/ KVP/ Bank Draft/ Bank Cheque which are duly pledged in favour of the B.D.O, Betnoti at the time of dropping of Tender paper as per revised codal provision i.e. Amended 2013 (Vide O.M.12366/W, Dt 08.11.2013)

of OPWD Code modified vide Office Memorandum No.5288/W,Dt 04.05.2016 of the Govt. in Works Department.

- 10. The Tenderer has to show all required original documents at the time of opening of the tender for verification.
- 11. The EMD amount will be forfeited, if the Tenderer breaks out from the Offer of acceptance of Tender, by the Competent authority.
- 12. Submission of more than one tender paper by a bidder for single work will be liable for rejection of all such tender papers.
- 13. On review of the Last performance of the work executed through B.D.O, Betnoti, the lowest-1 Tenderer may/ may not be considered for execution of referred project , though he/ she becomes lowest-1 Tenderer.
- 14. The Contractors who have failed to execute the project of this agency/ broke out from Execution process/ abandoned the project work midway/ those who have been declared by this agency to be defaulters otherwise will not be allowed to participate in the present tender process. If any such contractor participates, then his/ her papers will not be considered at all.
 - 14. GST shall be paid extra as applicable.
- 15. The undersigned reserves the right either to reject any or all tenders or cancel the entire process without assigning any reason thereof.
