Teams and Conditions:-

- The sale and receipt of bids documents shall available from the O/O the Block Development Officer Kaptipada from Dt-07/07/2021 to Dt. 29/07/2021 till 5.00 P.M. During working days
- Bids shall be received by the Block Development Officer, Kaptipada till Dt. 30/07/2021, 5 P.M. through Registered Post/Speed Post/drop box. The authority will not be held responsible for postal delay in the delivering of the documents or non-receipt of the same. During working days.
- 4. The tender will be opened in the office of the Block Development Officer, Kaptipada at 11.00 AM, on 02/08/2021 in presence of the bidders or their authorized representatives who wish to attend. If the office happened to be closed on the date of receipt /opening of the bids as specified, the bids will be received /opened on the next working day at the same time and venue. Bid documents can be purchased from this office against a non-refundable fee towards the cost of the document as indicated in the form of cash or demand draft issued from Nationalized bank as per DTCN in favor of the Block Development Officer, Kaptipada, may be deposited in shape of bank draft prepared on or before the last date of receipt along with the bid.
- 5. The Bidders are required to submit along with their BID" a BID SECURITY declaration" as per the office Memorandum No.5984 dated 27.04.2021 of works department Govt. of Odisha in lieu of Bid Security in the format annexed (As per Annexure-1)
- 6. Additional performance security deposit shall be deposited by the successful bidder before drawal of the agreement as per works department office memorandum No.4559 dated 05.04.2021 within 7 days of issue of L.O.A by the divisional Officer (Through email.) otherwise the successful bidder will be cancelled & bid security, if any shall be for forfeited at following rate as prescribed by state Govt. which may be in shape of TDR/ Bank Guarantee duly pleased in favour of the Block Development Officer, Kaptipada from any Nationalized Bank/ Scheduled Bank of India Counter guaranteed by the local branch in Bhubaneswar within 7 days of issue of L.O.A by the Tender Accepting Authority.

- 8. Bids must be delivered in the tender box having identification no 01/Kaptipada/2021-22
- 9. The following documents should be furnished along with the tender paper failing which the tender is liable for rejection.
 - a. Attested copy of the contractor registration certificate.
 - b. Attested Copy of PAN card/Labour License/GSTIN Certificate
 - c. Money Receipt of DTCN (Tender Paper) shall be enclosed in original.
 - d. Signed Copy of DTCN and Price-bid duly filled in and signed by the tenderer.
 - e. An affidavit regarding authenticity of the credentials.
 - f. Past performance of the contractor in the prescribed Performa.
 - g. No relationship certificate in the prescribed Performa.
 - h. Compliance to qualifying criteria if any.
 - i. The Mailing address of registered office/Site office of the bidders for future correspondence.
 - j. Attested Copy of Caste Certificate for SC/ST contractors desirous availing preference.
- 10. The tender is to be submitted in one cover along with all document described and documents required as per the relevant clauses of this DTCN and special conditions if any. The cover is to be sealed and super scribed as the bid of the works as mentioned in column No.2 of the tender call notice.
- 11. All the tenders where rate quoted is more than 15% less than the scheduled rate will be rejected and tender shall be finalized basing on merits of rest of bids. But if more than one bid is quoted up to 14.99% (Decimals up to two numbers will be taken all practical Purposes) less than the Estimated cost, the tender accepting authority will finalize the tender through transparent lottery system where all bidders/their authorized representatives, all the Tender Committee members will remain present.
- 12. Bid documents requested by mail will be dispatched by registered/ speed post on payment of an extra amount of Rs.500.00 over and above the cost of documents mentioned under col.7. The Block Development Officer, Kaptipada will not be responsible for the postal delay if any in the delivery of the documents or non-receipt of the same.

a) The Engineer Contractor seeking of exemption of E.M.D. is to be enclosed an affidavit regarding the number of tenders they have participated with exemption of E.M.D prior to date during the current financial year .Also he will have to produce his/her original license at the time of opening, so that the authority will enter the same in the license which is mandatory.

Adjustment of EMD given with other bids submitted previously is not to be entertained.

c) Fixed deposit holder as per works department order No 28838 dt 18.12.95 are exempted from furnishing EMD, but should enclose the copy of the exemption order along with the bid.

14. S.C./S.T. Tenderers can avail facilities as per Govt. circular.

15. The bidders shall have to furnish an affidavit along with the bid regarding the authenticity of the bid document

16. All bids received will remain valid for period of 90days from the last date of receipt of bids and the validity of the bids can also be extended, if agreed to by the bidders with the department.

Other details can be seen in the bidding documents.

18. If the L1 bidder does not turn up for agreement after finalization of tender, then he/she shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case L2 bidder if full fill ,other required criteria would be called for drawing agreement for execution of work subject to the condition, that L2 bidder negotiate at par with the rate quoted by the L1 bidder otherwise tender will be cancelled.

19. Submission of more than one tender paper by the bidder for a particular work will liable for rejection for all such tender papers.

20. The rates to be quoted by the contractor shall be excluding GST. The implementation of the GST rules by the GOVT of Odisha is to be accepted by the bidder at any point of time.

21. If the rate quoted by the tenderers is found to be same, tender committee will decide the tender.

- 22. The Block Development Officer, Kaptipada reserves the right to reject any or all the tenders without assigning any reason
- 23. In case of lottery need to be conducted in accordance with the works department order no. 12366 dt. 08/11/2013, the lottery will be held on later in the Block Conference Hall, O/O the Kaptipada Development Officer, Kaptipada, Mayurbhanj.
