- 2. The sealed tender paper will be received addressed to O/O the Block Development Officer, Tiring, Mayurbhanj, PIN- 757053 through Registered post/ Speed post/ Hand dropping in tender box at Block Office Tiring till 5.00 PM of 01.09.2021 in working days only. The undersigned will not be held responsible for any delay in the postal service even if dispatched before due date.

3. The BID must be accompanied will be accompanied with the signed copy of DTCN and price bid duly filled in and signed by the tenderer and requisite EMD @ 1% of the amount put to tender in shape of NSC/KVP/POTD/Time Deposit of any Nationalized Bank valid minimum one year from date of receipt duly pledged in favour of the Block Development Officer, Tiring, Affidavit about the authentication of tender documents. BIDs without EMD/ un-pledged EMD or in other shape and invalid PAN card/GSTIN certificate will not be consider and liable for rejection. - 12. The EMD will be forfeited if the tenderer backs out from the offer of acceptance of tender by the competent authority
- 13. The tenderer has to show all required original documents at the time of opening of the tender for verification
- 14 The contractor must have executed similar nature of works and financial turn over in last three years. The tenderers are required to submit the list of T&P possessed; list of works executed and successfully completed the civil works during last three years. The above information should be certified by the concerned authority not below the rank of BDO/Executive Engeneer
- 15 If the rate quoted by the tenders is found to be same, tender committee will decide the tender.
- 16. Additional performance security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event ,the only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of the differential cost i.e. estimated cost put to tender minus the quoted amount as an Additional Performance security in shape of demand draft/Term deposit Receipt pledge in favour of Block Development Officer within 7 days(seven days) otherwise the bids shall be cancelled otherwise the bid shall bid cancelled and the security deposit be forfeited .Further proceeding for black listing shall be immitted against the bidder.
- 17 If the rate quoted by the bidder is less than 15% of tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest of bids.
