Quotation Call Notice

Sealed quotations are invited in prescribed format from the interested agencies/ GPLFs / SHGs or individuals for supply of vegetable seed Kit for promotion of Mo Upakari Bagicha under Odisha Livelihoods Mission in Mayurbhanj district. The complete quotation paper in all respect should reach the undersigned on or before 20nd November, 2021 by 11.00 AM through Registered post / Speed Post/courier. The details of the terms and conditions can be downloaded from the website www.mayurbhanj.nic.in.


1. Bid Price:

- The price shall be inclusive of all duties, taxes and other levies payable by the dealer including transportation. The format of price bid specified in Annexure-I & II shall be used. Corrections, if any, shall be made by crossing out, initialling, dating and re writing.
- The Prices should be quoted in Indian Rupees only.
- The rate quoted by the bidder shall be fixed for the duration of the contract.

2. Evaluation:

The purchaser will evaluate and compare the bids determined to be substantially responsive i.e. which (a) are properly signed; and (b) confirm to the terms and conditions, and specifications.


- Payment shall be made through e-Transfer (NEFT) after submission of the bills, supporting documents etc. and delivery of the seed Kits at Block point.
- Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.
- Bid validity: Bid shall remain valid for a period not less than 60 days after the deadline date specified for submission.
- In case of breach of any terms and conditions, the purchaser will have the right to cancel the order/contract without assigning any reason thereof and nothing will be payable by the purchaser in that event and the security deposit shall also be forfeited.
- Any legal dispute arising out of this is subject to MAYURBHANJ district jurisdiction only.
- The bidders can collect documents from DMMU,OLM at DRDA,Mayurbhanj on all working days (10 AM to 5.30 PM) from 11.11.2021 to 20.11.2021 for use or it may be downloaded from website www.mayurbhanj.nic.in.

TERMS & CONDITIONS

- All seed should be packed separately and bunched together in a waterproof packet for each household.
- The bidder should produce sample of the product as per the specification during opening of quotation. The specification shall be strictly adhered to.
- Any damage caused during transport is the sole responsibility of the supplier.
- Blocks may conduct seed germination test on random basis before distribution to beneficiaries. The EMD of successful bidder should be deposited as security money towards quality assurance for 3 months of supply after selection.
- Seeds should be supplied within 15 days of issue of supply order at respective block head quarters.
- The authority reserves the right to accept or reject any tender without assigning any reason thereof.
- The bidder shall furnish Photocopy of PAN card & GST Registration certificate(not applicable for SHG/GPLFs)
- The bidder shall submit refundable EMD amounting to Rs.10000/- as DD in favour of "Odisha Livelihoods Mission(NRLM),Mayurbhanj payable at SBI,Main Branch, Baripada
