- 3. **EMD:** The Bidders are required to submit 1% EMD through online over the amount put to tender as mentioned in the Column No.5. Engineer contractor who wants to avail /claim EMD exemption shall have to furnish scan copy of affidavit along with tender declaring there in that he/she has not yet availed three nos of EMD exemption during this financial year and to show the original registration certificate to the tender opening authority for verification without which the tender will be rejected. SC/ST contractors desires of availing benefits as per works department resolution No.27748 dated 11.10.1997 and amendment thereto must submit affidavit for the same alongwith attested copy of caste certificate.
- 4. Additional Performance Security shall be deposited by the successful bidder before drawl of the agreement as per Works Department Office Memorandum No. 4559 dated 05.04.2021 within 7 days of issue of L.O.A. by the Divisional Officer (Through email.) otherwise the bid of successful bidder will be cancelled & bid security, if any shall be forfeited at following rate as prescribed by State Govt.(Details as per DTCN).
- 5. The Bid **documents will be available** in the website: <u>www.tendersorissa.gov.in</u> from **18.12.2023** from **10.00** AM to **01.01.2024** upto **5.00** P.M. for online bidding.
- 6. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-III or Class-IIII.

Bids received on-line shall be opened on **02.01.2024** at **11.00 AM** in the office of the Divisional Forest Officer, Baripada Forest Division in the presence of the bidders, who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
