NOTICE INVITING PROPOSAL

Sealed tenders are invited from the eligible bidders as per the eligibility criteria for supply of Bike ambulance for PRM Medical College & Hospital, Baripada.

- 1. The bidders have to submit their tenders in separate sealed cover (i.e. Cover "A" Technical Bid & Cover "B" Price Bid). Both the covers should be put into a third Cover "C" which must be super-scribed as "Tender for "Supply of Bike Ambulance".
- 2. The Cover "A" (Technical Bid) Should contain as follows:
- 1) Checklist with details of the documents enclosed in Cover "A" (as per Annexure-I) with page number. The documents should be serially arranged as per this Annexure I and should be securely tied and bound.
- 2) Manufacturing unit/ supplier, who has been blacklisted either by the Tender inviting authority or by any state Govt. or Central Govt. organization, is not eligible to participate in the tender for that item during the period of blacklisted. They should submit a declaration about this by a Notary Public. (Annexure-III)
- 3) Tender Paper cost Rs.2360.00 (2000+ 18% GST) (Rupees Two Thousand Three Hundred Sixty Only, Non-Refundable) in shape of Bank Draft in favour of Superintendent, PRM MCH, Baripada payable at Mayurbhanj.

- Bike should be having 150/160 CC motorcycle with side carriage.
- The side carriage should be well covered for privacy of the Mother/patient.
- The vehicle should be fit to run in the difficult area.
- 6) Copies of organization PAN.
- 7) Copy of organization Income Tax Acknowledgement Report (Financial Year 2022-23) and copy of the audited financial statement for the last three financial year i.e.2020-21, 2021-22 & 2022-23.
- 8) Photo copy of the up-to-date GST Registration certificate.
- 9) DIC/MSME/NSIC registration certificate.
- 10) Copy of Valid Manufacturing License of the manufacturer (s)/Import License by the Importer (also to be submitted by the authorized distributor).
- 11) In case of distributer, a valid authorization certificate required to submit from manufacturer.
- 12) All the tender documents should sign by the bidders at the bottom of each page with his official seal duly affixed.
- 13) Leaflet/Technical Brochures of the products/item offered.
- 14) They should quote the rates inclusive of excise duty, insurance (5 years Comprehensive plan), packing, forwarding, freight (door delivery) and exclusive GST (if any) for complete structure of bike Ambulance and should submit as elf-declaration about this.
- 15) They must submit the undertaking that they will supply the stocks within thirty days after receipt of the Purchase Order from this office. In case of non-supply, the authority may allow extension for a maximum period of 02 (two)weeks (14 days) after the stipulated date of supply with a penalty of 0.5% per week, which will be deducted from the purchase order value as "Liquidated Damage".
- 16) The supplier should have a minimum average annual turnover of Rs. 10 Lakh or more in the last three-year financial years i.e.2020-21, 2021-22 & 2022-23 and copy of the audited financial statement for the last three financial years for 2020-21, 2021-22 & 2022-23. (Annexure-II)
- 17) All documents must be self-Attested with Seal of the organization.
- 18) The product must having warranty period not less than one year.
- 19) The Bids will be submitted by Dt. 06.03.2024 at 5.30 PM. The technical bids will be opened on Dt. 07.03.2024 at 11\30 AM in the Committee Hall of PRM

Superintendent proposition ipada MCH, in the presence of the Bidders or their authorized representatives, who may be present at the time of opening. The representative of the bidders are advised to carry the identity card or a letter of authority from the tendering firms to identify their bona fides for attending opening of the proposal. The date of opening for Financial Bid will be communicated to the bidders after analyzing the technical bid. In case of absence of any bidder then bid document will be opened by the committee members.

3. General Condition:

- 1. Eligible bidders should submit their tender documents to the Superintendent, PRM Medical College & Hospital, Baripada through Speed Post / Registered Post/ Currier within the stipulated date & time as mentioned in the tender call notice.
- 2. Any tender documents received after the due date & time will be rejected and returned to the tender unopened.
- 3. Violating the tender terms and conditions & non-supply / partially supply, which is not as per technical specification, will declared as Blacklisted and disqualify the firm to participate in any tender of this district for a period of next 03 (three) years from the date of issue of the letter and their E.M.D. will be forfeited.
- 4. Tenders documents should be typewritten or computerized, failing which the bidders will be ineligible for consideration. No further correction will be allowed.

5. The Cover "B" (Price Bid) should contain as follows:

- Financial Bid must be submitted in the prescribed format as attached in Annexure- IV. No other document should be enclosed in the Financial Bid. The Financial Bid should be sent in a separate sealed cover called Cover "B" (Price Bid)
- 2) The rates should be computerized.
- 3) If there is difference between figures & words, words wilt be taken into consideration.
- 4) They should quote the rates inclusive of excise duty, insurance, packing, forwarding, freight (door delivery) and exclusive GST (if any).
