The bidders are to submit sealed tender papers by the due date only by Speed Post/Regd. Post/Dropped in the assigned drop box kept in the District Election Office, Mayurbhanj along with security money (Refundable) of Rs.30,000/-(Thirty Thousand) only in shape of Bank Draft/Banker's Cheque and Rs.1000/- (Rupees One Thousand) only towards the cost of tender paper (Non-refundable) in favour of OIC, Election, Mayurbhanj.

₹1. The interested suppliers/forms should submit quotations in a sealed envelope. All the pages of the tender papers should be signed with seal of the firms/agencies.

2. The sealed envelope containing the proposals must be delivered to District Election Officer and Collector, Mayurbhanj by Speed Post/Regd. Post/Dropped in the assigned drop box kept in the District Election Office, Mayurbhanj with super scribed the items of quotation. Bid received after due date will not be entertained and shall liable for rejection.

3. The tender paper can be obtained from the office of the District Election Office,

4. Photocopy of valid PAN CARD, GSTIN registration Certificate must be enclosed by the bidders/tenderers. The tenderers must submit GSTIN Return/ Income Tax clearance (proceeding 3 years) etc.

5. The tenderers must come with sample with specification at the time of opening of

the tender

6. Any legal dispute arises put of this subject to jurisdiction of Mayurbhanj only.

7. The quotation should have not been black listed by any Government organization. If found later on the action shall be initiated against the firm as per law.

8. Delivery must be made to the District Election Office, Mayurbhanj within seven

days from the date of order.

The District Election Officer and Collector, Mayurbhanj reserves the right to accept or reject any or all the quotations without assigning any reason thereof and also has the right to allot/distribute the work to L2 supplier/firm at the lowest (L1) rate in case of L1 bidder fails to deliver the items within the stipulated time.

have right to cancel the order/contract without assigning any reason thereof.
