Sealed tenders are invited from interested reputed Travel Agencies /Tour Operators or private individuals for providing One No of Non AC Diesel driven Bolero/TUV300/Sumo Gold/Ertiga or equivalent Vehicle which shall conform the following terms and conditions for official use in ICDS Project, Bisoi on Monthly hiring basis.

- 1.The Vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, proof of upto date tax payment etc. which are mandatory for plying of vehicle.
- 2. The office shall not be responsible for any damage/loss caused to hired vehicle or loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner what so ever. The hirer shall be responsible for all such litigation.
- 3. The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of Engine, Gear Box& different Coolant, Tyres and Tubes, Battery etc will be borne by the bidder.

4.It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.

5.In case of breakdown for reasons whatsoever, the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle.

6.In case the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.

7.In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.

8.Monthly hire charges and reimbursements towards cost of diesel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month as far as possible within 15 days of submission of bills by the service provider and no advance payment will be made.

9.In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.

10.A sum of Rs 5000/- shall be deposited by the intending bidders in shape of Account payee Bank Draft drawn in favour of the C.D.P.O ,Bisoi to be drawn at Bank of India ,Bisoi branch and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to the unsuccessful bidders.

- 11. Monthly hiring basis charges be quoted separately in the general bid information (excluding fuel and lubricants).
- 12. The details of the make and year of manufacture of the vehicle, registration no, mileage (Kms covered per litre) & name of the Driver with Driving License No and period of validity should be specifically provided in the general bid information to be furnished with the Tender.
- 13. The Tender completed in all respect should reach to the undersigned on or before 09.07.2024 by 1:00 PM and shall be opened on the same day at 3.30 PM in presence of the bidders or their authorised representatives at the Office chamber of the C.D.P.O, Bisoi.
- 14. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
- 15. The vehicle must achieve a fuel efficiency of 10 Km per litre .
- 16. The Driver must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 17. The Driver should be well behaved gentle and obedient in nature.

- 18. The vehicle is to be used for one year & if required the contract order may be extended for further more period.
- 19. The vehicle should be fitted with VLTD device as per letter No -LX-67/2022/13461/TC dt. 05.09.2023 of Transport Commissioner, Odisha.
- 20. The vehicle will be kept in front of office during office hour /working hour.
