Will be conducted in 3 blocks i.e. Rairangpur, Bisoi and Bangriposi awareness among the WSHG member /FPOs who are interested in jute cultivation, processing & value addition through diversified jute products with following terms and condition mandatory.

1. The NGO must have valid PAN numbers and GST registration with up to date income tax GST clearance certificate.
2. Previous 3 financial years Audited statement of accounts for (2021-22, 2022-23, 2023-24)
3. The NGO must not be black listed.
4. Preference would be given to the NGO who have past experience (Preference NJB empanelled) for similar assignments in Agriculture & Farmers Empowerment Department (The copy of the order / MoU/ Completion certificate etc. must be attached with the proposal.)

The Interested NGO are required to submit the application/ proposals in sealed envelope super-scribed as "**Application/ Proposals for selection of NGO for implementation of the programme on Capacity building & Skill development training of jute and jute diversified product under the scheme Intensive Agriculture Programme, State Plan for Mayurbhanj District**" as per the enclosed application format by registered/ speed post.
