- 2. Earnest Money Deposit:** The bid must be accompanied with E.M.D amount as specified against each work in shape of NSC/POTD/KVP/DD/POSB/FD receipt of the scheduled commercial bank duly pledged in favour of **BDO, UDALA**.
- 3. Sale and Receipt of Tender Paper:** The sale of the Bid documents will be made from the date of publication i.e. from **Dt: 06.11.2024 to 14.11.2024 from 10:00 am to 4:00 pm during office hours (on working days only) in the office of the Block Development Officer, Udala.**

- 4. Date of Opening of the tender Paper:** The Bids will open on **Dt. 20.11.2024 at 11.00 A.M.** at the, **Conference Hall, Panchayat Samiti, Udala, Mayurbhanj** in the presence of the bidders who wish to attend. If the office happens to be closed (holiday) on the date of receipt/opening of the bids as specified, the bids will be received/opened on the next working day at the same time and venue without further notice. However, date of tender paper opening may be postponed as per the convenience of the authority by intimating all the concerned tenderers through notice affixing to notice board at Office of the Block Development Officer, Udala, Mayurbhanj.
- 5. Additional Performance Security Deposit:** Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tenders per works deptt. Letter No. 4710 .dt 12.04.2022 In such an event, only the successful bidder who has quoted less bid price/rates than the estimate cost put to tender shall have

to furnish the exact amount of differential cost i.e., Estimated cost put to tender minus the quoted amount as additional performance security (APS) in shape of NSC/POTD/KVP/DD/POSB/FD of any nationalized bank receipt duly pledged in favour of Block Development Officer, Udala within 7(seven) days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder.

6. The following Documents should be furnished with the tender paper failing which the tender is liable for Rejection.
- A) **EMD Pledged in favour of BDO UDALA.**
 - B) **Self Attested copy of valid Contractor Registration Certificate.**
 - C) **Self Attested copy of valid Pan Card & GST Certificate.**
 - D) **SC/ST Contractors submit original Affidavit in support of cast certificate and attested copy of Cast certificate.**
 - E) **Bank Draft towards cost of Tender paper in favour of BDO, UDALA in original**
 - F) **P.H Contractor should submit original Affidavit in support of PH certificate regarding EMD Exemption.**
 - G) **An Affidavit in support of the authority of documents including no relation certificate should be attached with Tender Paper.**
 - H) **Signed copy of DTCN and price-bid duly filled in and signed by the tenderer.**
 - I) **An affidavit regarding authenticity of the credentials**
 - J) **The mailing address of registered office/site office of the bidders for future correspondence.**
 - K) **An affidavit to the effect that there has been no conviction/imprisonment for an offence involving moral turpitude.**
7. Engineering Contractors desiring to avail the exemption facility of EMD should submit an original affidavit as regards, the fact of availing award of work without submission of EMD/ISD during the current financial year. He should also produce original contract licence at the time of opening of tender document to make necessary entry to that effect as such facilities are limited to three participations in tender during a financial year. Otherwise, their tender will be liable for rejection.
8. The SC/ST Contractors desirous of availing preference should submit an original affidavit in support of caste certificate and attested copy of caste certificate, otherwise their tender will be liable for rejection.
9. G.S.T. as applicable shall be paid extra over and above the work value. The Contractor shall however be required to submit the TAX INVOICE along with the R.A. / final bill released of the G.S.T. amount by the department.
10. Shortfall of any required documents, Tender paper is liable for rejection.
11. A bidder can submit only one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular tender will liable for rejection of all such tender papers.
12. Other details can be seen in the bidding document.
13. All the tender where rate quoted is more than 15% less than the scheduled rate will be rejected.
14. Other details can be seen in the bidding documents.
15. All bids received will remain valid for period of 30days from the last date of receipt of bids and the validity of the bids can also be extended, if agreed to by the bidders with the department.
16. If the L1 bidder does not turn up for agreement after finalization of tender, then he/she shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case L2 bidder if full fill, other required criteria would be called for drawing agreement for execution of work subject to the condition, that L2 bidder negotiate at par with the rate quoted by the L1 bidder otherwise tender will be cancelled.
