#### Terms and Conditions:-

1. The sale and receipt of bids and tender documents & tender paper shall be available from the O/O the Block Development Officer, Tiring from 02.01.2025 to 21.01.2025 (Except Sunday & Holiday) from 11.00 AM to 5.00 PM and sale will be closed on 21.01.2025 at 5.00 PM on payment of cost of bids documents in shape of Demand Draft (Non- Refundable) issued from any Nationalized Bank drawn in favour of the Block Development Officer, Tiring payable at Bank Of India, Nuagaon, Tiring/ deposited by Cash.

2. The sealed tender paper will be received addressed to O/O the Block Development Officer, Tiring, Mayurbhanj, PIN- 757053 through Registered post only till 5.00 PM of 22.01.2025 in working days only. The undersigned will not be held responsible for any delay in the postal service even if dispatched before due date.
3. The BID must be accompanied with the signed copy of DTCN and price bid duly filled in and signed by the tenderer. The lowest bidder will deposit ISD/EMD @1% of the tendered amount before execution of agreement as per OPWD Code. Invalid PAN card/GSTIN certificate will not be consider and liable for rejection. The tenderers must to be writing in capital letter (TENDER PAPER with NAME OF THE WORK) on the right-side top of the envelope containing the tender documents.
4. The bids received will be opened on 11:00 AM of 24.01.2025 at O/O the Block Development Officer, Tiring in presence of the tenderers or their authorized agents who wished to attend and Block tender committee.
5. The bidder shall submit one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular work shall liable for rejection.
6. If the office happens to be closed on the date of receipt/ opening of the bids as specified the bids will be received/ opened on the next working day at the same time and venue.
7. Transfer or adjustment of EMD & ISD amount with other works will not be entertained. The EMD of unsuccessful bidder will be refunded.
8. Excess bid amount quoted by the bidders if any, in respect of any work shall not be accepted.
9. The successful tenderer quoting less than the amount put to tender has to deposit the differential amount i.e. (Tender schedule amount - (minus) his/her tendered amount) in shape of NSC/KVP/POTD/Bank Deposit receipt of any Nationalized Bank duly pledged in favour of the Block Development Officer, Tiring at the time of agreement.
10. The tenderer are requested to submit an affidavit in support of "No Relation" certificate (not below the rank of Assistant Engineer).
11. The following documents will be furnished in the sealed tender paper by tenderer failing which the tender is liable for rejection.
  - (i) self-attested copy of the Contractors registration certificate.
  - (ii) Self attested copy of Pan Card & GST clearance certificate with active GSTIN
  - (iii) Money receipt of DTCN (Tender copy) shall be enclosed in original
  - (iv) Attested copy of Caste certificate for ST/SC contractor desirous of availing preference
  - (v) The labour licence must be submitted at the time of agreement
  - (vi) EMD in shape of DD.

12. The EMD will be forfeited if the tenderer backs out from the offer of acceptance of tender by the competent authority
13. The tenderer has to show all required original documents at the time of opening of the tender for verification
- 14 The contractor must have executed similar nature of works and financial turn over in last three years. The tenderers are required to submit the list of T&P possessed; list of works executed and successfully completed the civil works during last three years. The above information should be certified by the concerned authority not below the rank of BDO/Executive Engineer
- 15 If the rate quoted by the tenders is found to be same, tender committee will decide the tender. through a transparent lottery system where all bidders or their authorized representatives /Tender Committee of Block remain present.
16. Additional performance security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event ,the only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of the differential cost i.e. estimated cost put to tender minus the quoted amount as an Additional Performance security in shape of demand draft/Term deposit Receipt pledge in favour of Block Development Officer within 7 days(seven days) otherwise the bids shall be cancelled and the security deposit will be forfeited. Further proceeding for black listing shall be immitted against the bidder.
17. For building and other construction workers welfare cess @1% (One Percent) of the cost construction shall be deducted from bills
18. The authority reserves the right to reject any/ all tenders without assigning any reason thereof.




